## President's Perspectives . . . Joyce Smith

General Assembly 2004 is history. It was a positive and uplifting event. The Service of the Living Tradition was moving with its large number of ministers (62) recognized for Preliminary Fellowship; and almost as many (51) for Final Fellowship. There were 16 ministers recognized as completing full-time ministries and 18 of our ministers who died over the past year including our former President, Peter Raible. It is a sad occasion when we recognize the names and personally know more of the ministers who die than those coming into our Fellowship either in Preliminary or Final Fellowship. The number of years which those who died gave in service to our denomination was large. Some lived to an honored old age and some died far too young. We will miss them personally and as a source of memory and hope.

We conducted two workshops and held the lunch for our membership. The workshop on "Aging to Sageing" was well attended and well received. The workshop featuring the results of our Survey and our plans for Financial training was not scheduled at a good time and had only a handful of dedicated people in attendance but the dialogue was lively and interesting. We had about 35 at our luncheon which featured the best meal for the least amount of money at the whole G.A.

In October we will have a Board in which half the members are new to the Board and three of the other members have been there for one year. One of my hopes is to brainstorm about what programs or ways we can devise to interest and serve the newly retired ministers and partners as well as meeting the needs of our older members. Currently we have two functioning conferences the Northeast Conference and the Western Conference. The Northeast Conference has the advantage that people can drive from their homes to attend. The Western Conference has the disadvantage of being expensive because many people have to fly to attend. The Midwest conference and the Mid-South Conference suffer by having not enough people willing to take leadership roles. These are some of the realities we face in the future. Any suggestions from our membership would be welcome. What are your needs and desires for your organization?

Responding to an ad in the UUA World, I spent five months this past winter working with a small fellowship in Yuma, Arizona. I worked 8-10 hours a week, providing a number of Sunday services, conducting a few workshops, and dealing with the future of the fellowship. The experience really energized that small fellowship and yet left us lots of time to explore the desert which Anne, my partner, and I had never had the opportunity to explore before. The fellowship provided a \$3000 budget which covered rental and utilities for an older park model in a senior citizens park. We really enjoyed the people in the fellowship, watched them get excited about the possibilities of liberal religion and, in addition, were able to avoid a very harsh winter in Nebraska. ***Fred Lipp* : THE CAGED BIRDS ARE FREE**

In retirement, I have the rare and wonderful privilege of representing students from primary school to university in Cambodia. I am the Founding President of the Cambodian Arts and Scholarship Foundation, a 501(c)(3). I spend about six weeks a year in Cambodia. The rest of the time I raise funds and work out of our home in Whitefield, Maine. From the seed money of \$50 on 9/11, our budget has grown to \$35,000 a year.

Our total program involves about 250 students. There are more than 120 students in our Roof School -- called so, because the three little shelters are built of palm branches and lined with rustic benches. The school usually blows down in the Monsoon. We are working towards a permanent, concrete building, the first in this region of the jungle since the devastation by the Khmer Rouge.

The remainder of our program that represents our general mission is the selection of outstanding, highly motivated young women who we feel will not only further their education, but will, in time, help their community. In our venture, I have found amazing help and reassurance in reading Kidder's book about Dr. Paul Farmer's work, *Mountains Beyond Mountains*.

Perhaps the most exciting recent news for me on a personal level is the launching my book *The Caged Birds of Phnom Penh* translated into Khmer by Chhoeung Chheng Hak, and published by the French organization SIPAR. The English version won numerous awards including Notable Book for a Global Society by the International Reading Association. I leave for Cambodia June first to share the new edition in remote regions of Cambodia. This is the biggest kick in my life. Two new multicultural books of mine just out: *Tea Leaves & Bread Song*. ## News from the Office of Church Staff Finances

*Edgar Peara* sent us an article suggesting a way to choose socially responsible investments. After some email debate and discussion with Ralph Mero, we felt that listing specific funds was too much like an endorsement. So here is an excerpt from Edgar's article, and Ralph's accompanying advice.

*From Edgar:* Socially screened funds or "green" funds avoid investing in tobacco, alcohol, gambling, weapons, and polluting companies. Such funds now represent a ninth of all professionally invested securities.

*From Ralph Mero, Office of Church Staff Finances:* I would be very reluctant to see the UURMAPA newsletter, Elderberries, recommending active fund investing to our retirees. I applaud Edgar's interest in socially responsible funds, but few of our constituents have money they can expose to the risk of the current stock market, even through SR funds.

The UUA retirement plan will be adding a stable of SR funds so that participants will have a choice between a regular fund and a SR fund in each style category (large cap growth, mid cap, small cap, bonds, international, etc.) Retirees with accounts in the UUA plan can consider one or more of the funds that have been studied and approved by the UUA Compensation, Benefits, and Pension Committee.

My strong suspicion is that the US stock market is going to flounder or perhaps decline as the Baby Boomers begin to retire and sell their investments, and I would hate to see our retired UU clergy buy into a ship labeled Disappointment.
