## President's Perspectives . . .

Colorful fall leaves continue to carpet the earth here in northern Michigan, a reminder of the transition of the seasons as well as transitions in our personal and family life.

In October your Board convened to continue our meetings with UUA staff. From **Beth Miller**, Director of Ministry and Professional Services, we learned about the expectations for UURMaPA as a new member of the Professional Leadership Coordinating Council (PLCC) that include developing guidelines for right relationships for our members. The Board appointed two Task Forces: **Andy Backus** will chair the Task Force to draft a statement for our clergy members to continue abiding by UUMA covenants and **Barbara Prairie** will chair the Task Force to begin developing guidelines for partners. The Board realizes that developing partner guidelines will require more time because this is new territory for our membership.

We heard the results of two major surveys:

1) **Ralph Mero** and **Marj Lynn**, (UURMaPA representative to the Council on Church Staff Finances) presented the results of the Financial Survey (see report below). Ralph continues to see that financial assistance is available to those in need. Contact Ralph ([rmero@uua.org](mailto:rmero@uua.org)) if you are in need of a heating grant this winter.

2) **Eleanor Richardson** reported on the Ministerial Activities Survey that confirmed our clergy members are active in serving congregations and the community in varied and numerous ways.

On behalf of **Glen Snowden**, chair, **Barbara Prairie** reported for the Creative Sageing Committee about the Award that will be given in 2008. It comes with a \$500 prize. Deadline for entering is Feb. 15, 2008. (article below).

**Makaanah Morriss** was welcomed as new Board member and Caring Network Chair. She reported the transition is going well. She will administer the new practice of sending flowers to clergy when a partner dies.

We missed two Board members, **Fia Scheyer** and **Carl Thitchener**, due to health problems. It is with deep regret that the Board has accepted **Carl's** resignation. We thank him profoundly. He has been an attentive list manager, web instigator and thoughtful and wise contributor at meetings. As an example of his devotion and thoroughness he had our 2007- 08 Directory printed a few days before entering the hospital for surgery. When you receive it, think of him with abiding gratitude. I am grateful to **Andy Backus** who has volunteered to become temporary list manager. The Board charged him to find a web designer for an expanded UURMaPA website, setting aside up to \$1000 for that purpose.

Which brings me to the topic of budget and finances. As our organization matures ---yes, even a retirees organization can mature---it is imperative we expand our website, provide caring networkers scholarships to regional conferences, and encourage more face to face gatherings among our scattered membership. I believe we will bring experience and wisdom to the Professional Leadership Coordinating Council (PLCC), but there will be a fee attached. You have been generous in the past when asked to support your organization. Thank you! And I trust you will continue.

I send Thanksgiving wishes that you may enjoy the occasion remembering and giving thanks for our religious ancestors with family and friends.

## Proposed Bylaw Amendment

The Board proposes two small changes in our mission statement so that it would read: *"Acting in conformity with the purposes and principles of the Unitarian Universalist Association, the purposes of this organization shall be to serve Unitarian Universalist congregations and their Association, and to enhance the well-being of retired Unitarian Universalist ministers, their life partners and surviving life partners and to provide such programs and activities as may be feasible for their benefit."*

Note that "UU congregations" has been added to better reflect what we actually do. And "ministers of Religious Education" has been omitted so that "Unitarian Universalist ministers" stands as the general term, which also covers interims and community ministers as well as MRE's.

## Early UURMaPA History

This history of UURMaPA is taken from information gathered in an October 22, 2002, interview of Shirley Hadley, Arnold and Horace Westwood, Keith Munson and Ralph Mero moderated by Dorothy Hopper.

About 1982 Harold Hadley who was retired first began asking questions like....what are the resources for older and retired clergy. He and his wife Shirley hosted conversations with other retirees in the Amherst, MA area that included Harold and Arnold Westwood, Walter Kring, and later Keith Munson. From the beginning spouses were included in the circle.

There was no organization or money to support programs for retirees, so with the encouragement of UUA staff person, Ron Clark, Harold Hadley went to the Veatch Committee, receiving \$5,000. And then the UUA provided one or two thousand dollars to the fledgling organization. The New York State Universalist Convention gave money to UURMaPA until 2004.

With the funds, the first Conference was held October 1985 in Petersham, NH. By-laws were drawn up and adopted and officers were elected. Harold Hadley was president, Robert Holmes vice president, Walter Kring, secretary, William Gardner. treasurer and Al Perry, Elderberries editor. Harold served as president for 6-8 years, then Keith Munson was president for about 5 years. Gradually the Caring

Network was established with Freda Carnes and Peg Johnson spearheading the program.

Under Keith Munson's presidency, term limits were established for Board members to ensure new people would populate the Board. It was finally established that membership included retired clergy, partners of retired clergy and surviving spouses of retirees. After considerable conversation, it was agreed there would be no dues required for membership, but voluntary contributions would support the organization and its budget. And the practice of having a UURMaPA luncheon at GA for current members and new members was begun.

Gradually Conferences originated in other parts of the country, namely on the West Coast, in the South and Mid-West. Each Conference was self perpetuating, arranging for the leadership for carrying on the planning of subsequent Conferences.

From other written records the Unitarian Universalist Retired Ministers and Partners Association was incorporated with The Commonwealth of Massachusetts in 1997 when Max Gaebler was president with Ralph Mero listed as resident agent of the corporation at 25 Beacon Street.

Under the leadership of treasurer, Fred Campbell, UURMaPA received 503 (c) status in 2004.

Last spring you received a **Financial Planning Survey** from the UUA Council on Church Staff Finances, addressing one of the Council’s objectives, “By the year 2010, 90 % of retired ministers, church staff and survivors will have income equivalent to at least 300% of the Federal poverty level.” We also solicited information to assist in current and future financial concerns of UURMAPA members. 80% of the surveys were returned to the Council. Ages ranged from 58-100. For more detail, contact Joyce Stewart, 617/948-6421 or [jstewart@uaa.org](mailto:jstewart@uaa.org). The Council gained a great deal of valuable information from your responses. We learned:

- 76% meet or exceed the 300% guideline mentioned above, short of the goal of 90%.
- Income from all sources for a minister, partner or survivor individually ranged from under \$5,000 (3) to over 80,000 (35) with the greatest number between \$20,000 to \$40,000. For those living with partners, the income range is increased.
- 66% of you would take advantage of financial planning information if provided.
- 59 respondents were not aware of the UUA Service Gratuity.
- Many were not sure about the definition and terms of the ministers’ housing allowance.
- Too many were unaware of the help that is available through the charitable societies that are members of the Council.
- The first most pressing concern of those responding is “health/illness” (48 of 177) and the second is “outliving income/assets” (50). However, 36 felt they “were in good shape” or had no concern.”
- Respondents were effusive in their gratitude to Ralph Mero and Joyce Stewart

### A sampling of answers to the question on your most pressing financial concerns in retirement:

“Long term illness. I have been rejected for long term care insurance.”

“We are running out of money...every day I pray to be relieved by death.”

“To simplify our life regarding managing assets and deciding how to maintain the income stream.”

“Money will not be sufficient.” / “Lack of long-term medical care.”

“No concerns.” / “I’m ok.” / “None at the moment.”

“I would have extreme difficulty with my finances without the aid from UU.” / “Rising medical costs, outliving assets.”

“Income to meet the rising costs of living, especially energy costs.” / “Inflation and medical costs.”

The comments showed that there are many serious concerns and thoughtful evaluation of how one’s situation may change. At future meetings, the Council will address our goals in light of concerns facing UURMAPA members. Thanks to all who took the time to return the survey, thereby helping us with that task.

The Independent Affiliates afford the opportunity for various approaches to religious traditions and thought, such as Christian, Jewish, Buddhist and Humanist, to meet others of like mind in our vital, vibrant religious movement.

The Independent Affiliates have helped to keep our congregations on the cutting edge of religious and social thought.

We strongly urge you to reconsider your decision made before reflection on the many contributions of the IAs to our congregations and the Association.
