## A Fallen Giant

#### An Editorial

Which of our colleagues served for thirty-nine years (1936-75) in a Boston church; during part of his ministry it was the largest Protestant church in Boston? Donald Lothrop, who died on February 20 at the age of ninety-six. The church—founded in 1920 by Clarence R. Skinner—was Community Church. Many of its Sunday services were held in Symphony Hall.

Don was a social activist. He supported Spanish democracy in the 1930's, defended Sacco and Vanzetti, had an integrated church long before the civil rights movement, welcomed speakers such as W.E.B. DuBois, Rabbi Stephen Wise, and African liberation leaders to his pulpit—on one occasion he was physically attacked when he invited a supporter of Fidel Castro to speak.

His most defining moment came in the McCarthy era in 1958 when he was accused by a commission of the Massachusetts legislature of "giving aid and comfort to the Communists." He replied:

"Gentlemen, I plead guilty to this charge. I have given aid and comfort to all kinds of people, black and white, Jew and Gentile, Catholic and Protestant, Mohammedan and Buddhist, rich and poor, capitalist and communist, democrat and anarchist. I have never selected those who use my ministry nor have I ever refused. My exemplar is one, Jesus of Nazareth, who feared not to associate with and to minister to prostitutes, thieves, and tax-gatherers. He believed in virtue by association, not guilt by association."

In the words of John Haynes Holmes, New York City minister of another of our Community Churches:

Memory keeps with loving care Deeds they did and tales they told. But living men are hard to spare.

A giant has fallen. I will miss him.

# A Letter From Sylvia Falconer


