From Your President ... "Denial" Peter Raible

I was reminded recently of the old observation that when Americans become tourists, the condition they strive most to attain is not to be taken as tourists. "I can't stand old folk!" was a vehement response I received from an eighty-year-old cleric, when I asked him why he never attended UURMAPA conferences. Since he could hardly pass for anything but a senior, I knew he meant that he found his retired brothers and sisters were too limited in their interests. I thought of other comments I've heard in the last year or so about older clerics from other ministers and their partners:

- 1) "My life is more than preoccupation with my medical issues."
- 2) "Why are the only things important to us, things that happened years ago?"
- 3) "What do we really do to minister to one another?"
- 4) "How can we be helpful rather than hurtful in the life of the churches we attend?"
- 5) "Why can't we hear more about significant activities presently engaged in by retired ministers and spouses?"

I have no profound answers to such comments, but I know that the key is participation. We should provoke one another to share comments on what the significant issues in our lives are. We should make our gatherings reach beyond mere entertainment to engage us with the issues concerning our retired ministers today. We should be willing to share vignettes that might have relevance to those still engaged in active ministries. In short, we need to make sure that we try to bring our insights from experience to the contemporary ministry.

We also have a responsibility to be sure that we loft our issues of senior life before our colleagues and our laity in active leadership positions in the UUA. We have much to give and some things to receive. Let us begin by taking our collegiality in UURMAPA with seriousness, which lacks not humor.

UURMAPA Is Now An Affiliate of the UUA

Word has been received from the UUA that UURMAPA's application for Independent Affiliate Status has been approved.

Money Management Matters from Mero

With the poor stock market performance in the past two years, it is tempting for retirees to let a stock broker take over the funds in their account in the UUA retirement plan. Brokers are adept at pointing out how their firm can do better than the Fidelity or socially responsible mutual funds. Or so they say.

This can be a costly mistake if it cancels out the tax benefit of the retired clergy housing allowance so that future withdrawals from the brokerage house become subject to US income taxes.

We encourage retired ministers with accounts in the UUA retirement plan to use the Fidelity Managed Income Portfolio II for the bulk of their assets, and leave the money in the plan. The FMIP invests in contracts with the world's largest insurance companies, and has traditionally had better earnings than money market funds, while also being immune from stock market fluctuations.

Retirees may want to reduce the amount of their monthly or quarterly withdrawals from their accounts in the UUA plan to the minimum necessary for their immediate expenses of daily living. Hopefully the market will rebound so that a better return on investment is realized in the years ahead.

When retirees receive their 1099 form from Fidelity next January for their 2002 tax returns, the dollars they have asked to have considered a retired clergy housing allowance will be noted as "tax status undetermined," thereby simplifying having those dollars excluded from taxable income on the 1040 tax returns for 2002. A silent pause and then he said, "For murdering my wife!"


Not knowing quite how to respond I turned to the prospective bride who had a broad smile on her face. "How does that make you feel?" I queried.
