## **UU Ministerial Couple Honored Posthumously**

In February 1939, the Rev. Waitstill Sharp, 37, a Unitarian minister, and his wife, Martha, 33, of Wellesley, MA, set aside personal concerns for a vastly more urgent cause. Leaving their two young children behind, they arrived in Czechoslovakia a month before the German occupation and began assisting Prague's growing refugee population. Over the next two years, the Sharps helped secure food, shelter, visas, and freedom for hundreds of Jews and non-Jews targeted by the Nazis. Now deceased, the couple seldom spoke publicly about their work. But last November, their rescue efforts spoke loudly for them. And an international honor previously bestowed upon only one American was added to their legacy. The Sharps were chosen Righteous Among the Nations by Yad Vashem, the Holocaust remembrance authority in Jerusalem. Among past honorees is Oskar Schindler, whose story inspired "Schindler's List."

#### Medicare D

**From Dick Allen**: What he's learned from navigating Medicare D: "I will save several thousands of dollars a year with the new plan," he writes. [I have also been researching this, and concur with Dick on the savings and the steps – EMR, editor]

- 1. Are you in a medical plan right now that has provisions for prescription drugs? If you are, there is a good chance that you will not save any money, although you should contact the plan and ask if the new Medicare D will reduce your costs.
- 2. Are you covered by Medicare A or B? If you are, you need advice and information and can get it.

**Step one**: call 1(800) 434-4227. That is the Medicare number. Tell them you need help in finding the best medicine provider. They can tell you how to contact a senior assistance organization in your area to do the computer work.

**Step two**: Contact that local senior organization. Have a list ready of your prescriptions, the dosage, and what you pay each month for them. Also tell them what pharmacy you use and if you are flexible. They will work up different options from the Medicare website and advise you about choosing a prescription insurance provider. They are wary about advising, but if you want to spend the lowest amount possible yearly, ask them that, and they will tell you. Get the phone number of that insurance company, or the lowest three.

**Step three**: Call the selected medical insurance company, confirm the information given, find out how to get the medicine, and sign up. --Dick Allen, 500 Hilltop Drive, #247, Redding, CA 96003 Fax: (928) 438-1876; Phone: (530) 247-7661

#### In Memoriam

Reverend Michael Edward Boardman, 68, died Dec. 9, of PSP (progressive supranuclear palsy). He had dreams of becoming a dairy farmer, but he soon realized one must have money to buy a farm. Instead, he entered Starr King School for the Ministry. He served in Whittier, CA, and later at First Parish of Sudbury, MA, First Parish in Brookline, Eliot Church of South Natick, and several interim ministries. Shortly after an incorrect diagnosis of Parkinson's, Michael retired in 2002 and moved with his wife, Barbara Prairie, to Berea, KY. Despite declining health, he participated in various organizations, converted to Catholicism and regularly attended mass at St. Clare. He is survived by Barbara; daughters Katherine Edwards and Sheila Boardman; stepdaughters Adrienne Cruise and Karen Ransom; and five grandchildren. A second service will be held in South Natick in March.

*Yvonne Giles*, 81, wife of Rev. Philip R. Giles of Harwich, MA, died Dec. 10, 2005. Among other churches, they had been together at Muncie, IN; and Denver, CO. **Reverend Harold J. Quigley**, 92, of Kent, OH, died Feb. 5, 2005. He was ordained in 1939, but fellowshipped in 1960. He had served in Meadville, PA, from 1960-62 and retired in 1983. Mark of Asheville, NC; Keith of Tacoma, WA; Terry of Holyoke, MA; Rev. Lisa of Havre de Grace, MD; Scott of Wilmington, DE; and seven grandchildren. ### From Ralph Mero

Retired ministers who have **assets in IRAs** funded in connection with work in ministry may still roll these dollars over into the UUA Retirement Plan managed by Fidelity Investments. This simplifies record-keeping, may save on management fees, and can make more dollars exempt from income tax if used to maintain a residence. Contact Fidelity's Ben Donner at 800/248-4213, ext. 3131. The Fidelity Inflation Protected Bond Fund may worth considering as an investment if you feel inflation lies ahead.

People continue to ask about a **UUA health insurance program**. We have learned from other denominations with self-funded health plans, and are encouraged that a UUA plan could be viable. The UCC, Presbyterians, Methodists, Episcopalians, Southern Baptists and many others all operate self-funded plans for the clergy and staff, and headquarters staffs. As of January 2006, we are still unsure if there will be enough UU congregations willing to use an Association plan for their ministers and staff, but we hope to roll out a model plan for consideration this spring. If there is enough enrollment and the rates are affordable, such a plan might be effective January 2007.

The **Ryder Fund** is a resource that stems from the Illinois Universalist Convention. The proceeds provide financial aid grants for retired ministers who reside in the Central Midwest District, some of whom are in situations of financial hardship.
