
David Johnson and Peter Haslund were welcomed to the Board as vice president and member at





## Challenges for Partners

#### **Progress Report of the Partner Task Force**

Active and retired ministers have "guidelines" to spell out their relationships with each other and with current and past parishioners. However, we ministers' partners are generally in less well-defined territory. What does it mean to us, as partners, when the minister retires (or dies)? Do we just go along "business as usual?" Or do we have to reconsider our role in a congregation?

Barbara Prairie (chair), Eleanor Richardson, Peter Haslund, and Chris Lilly Backus are a partners' guidelines task force for UURMAPA. We met in March to share experiences and to weave together insights shared by other partners who had written us. Here is our first list of "Challenges." We invites partner to share insights on what works (or doesn't work) for you. We will blend this wisdom into short essays, hopefully useful to all of us. Send to Barbara Prairie, bprairie@adelphia.net.

<u>Discovering Unmet Needs</u>: What would you do if you have more time? We all have unmet needs in our lives. When the minister retires we may ask ourselves what those needs are. For instance did you always want to teach belly dancing or go sky-diving, but (alas!) didn't because of the demands of your partner's ministry? How might you meet those needs after retiring? Where would you go to meet them?

What are you glad to get rid of? Many partner questionnaires (2006) returned indicated relief that the duties of ministry were behind the partner. Are you one of those? Embrace the freedom!

<u>When the Minister Retires and the Partner Doesn't</u>: A source of stress on any relationship, perhaps especially so given the level of engagement demanded of the minister during active service as contrasted with retirement. How does this impact the partner?

When the Retired Minister Dies and the Partner is left alone: What happens when the minister dies? How does this change the roles in their relationship? How does this affect the partner's relationship to the former and/or new congregation?

**Post-Retirement Loneliness and How to Cope:** The ministry can be a lonely occupation. We are amidst people to whom we are intimately connected, yet the constraints of the ministry separate us. When the minister retires we may lose the status automatically conferred upon the ministerial family. How do we find community where we are heard, cared for, and can care for others in a fulfilling way?

**Being Displaced!** Not all transitions result in a positive relationship between the incoming and retiring Minister. What are the consequences for the partner and for the congregation when this happens?

<u>Financial Well-Being</u>: Planning an Effective Retirement. Did you figure out what expenses you would have and how you were going to pay for them? Did you telephone the office of Church Staff Finance at 25 Beacon?

Post-retirement connections with members of the congregation: UUMA guidelines urge limited contact

between the minister and members of the congregation. How might this affect partners who may have developed a strong social network that includes members of the congregation?

<u>Separation from Church and Re-entry:</u> What activities are appropriate for a partner? Are the options different after the minister retires? What sensitivities do the partner/minister and congregation need to keep in mind? How does one assess the perception of others and how much difference does this make?

<u>Transition to John and Jane Q. Pew:</u> Can we return to the pew as "just another parishioner?" Or do we simply know too much? Can we function only in roles we have had supporting our minister-partner -- or in our own spheres within the congregation? How do we participate in church life without threatening the settled minister (who may have less experience) or his or her partner?

**Non-local UU Participation:** Have you found meaningful participation outside the local congregation (e.g. cluster, district, national)? How do you find these opportunities?

<u>Choosing Not to Attend Church:</u> It works well for some to totally let go, not have to be anywhere on Sunday morning and to "just be". One widowed partner shared her glee, upon remarrying, of staying home in bathrobes and enjoying their new life together. A divorced partner relished having a mimosa in bed on Sunday morning. Do these scenarios have any appeal for you?

**<u>Does Gender Matter?</u>** When the minister retires, is the experience different for male and female partners?

<u>Doing It Together – facing the Minister's Retirement as a Team</u>: Are you included in the de-installation ceremony? Have you sat down face to face with your partner and talked about your future? Have you made space without distractions for these conversations in this transition?

<u>Identity in Transition</u>. A minister is a public figure, and the retired minister may lose that status. How may this affect the partner?

**Separation from Congregation upon minister's retirement:** UUMA guidelines say "stay away for 1 - 2 years." Does the partner join with the minister in observing this? Is there a "statute of limitations?" Is it different whether you move or stay?

## Colleagues: Please Archive Your Papers

Nancy Doughty, asked me to remind all of us – now – to archive our papers at an appropriate library or repository. This includes sermons, articles, essays, book manuscripts, worship material and other related writings, correspondence, biographical date, clippings, and photographs. No thoughtful history and analysis of our liberal movement can be written without access to the archives of our organizations and religious and lay leaders. There are many excellent libraries where your material can be placed: our theological schools - Meadville/Lombard, Starr King, and Harvard - as well as state historical societies, colleges and universities. The important thing is that you donate your papers to a library with the resources and staff to process and preserve them.

Talk with their archivist. Most libraries have websites with guidelines on making a donation and what papers should be saved for future scholars. Do it now, or at least let those who survive you know where to deposit your ministerial records. As C. S. Lewis in William Nicholson's drama Shadowlands observes: "You can't hold on to things. You have to let them go."

## In Memoriam

Evangeline Bachelder, 87, died Nov. 12, 2007, in Melrose, MA. She was the widow of Rev. Horace
Bachelder. They served at Atkinson Church, Oregon City, OR, from 1946-1971, where Evangeline directed a
30-voice junior choir, and often composed music. She composed a hymn, "I Held the Planets in my Hand"
which was pasted into the hymnal and sung often by the (then) 600-member church. Under their leadership, the
church went from Congregational to Unitarian in 1959. They moved to Plymouth, MA, in 1971, where Horace
ministered until his death in 1981. Evangeline again directed the Jr. Choir. Letters may be sent to Ed

Reverend Robert D. Botley. 84, died March 28. He served in the Army Air Corps in World War II, then served Congregational Churches in Sedgwick, CO; Pinedale, WY; and Rapid City, SD. In 1961, he joined the UUA and served the San Mateo Unitarian Church in San Mateo, CA. He marched with Dr. King in Selma. After a long bout with cancer, Rev. Botley retired early from formal ministry. As his health improved, he started a business, Specialized Yachting Services, then an accounting business. In 1999, the Botleys moved to McKinleyville, CA, joining the UU Fellowship. Botley loved wilderness, and won awards for his landscape photography. He built a boat and sailed to Mexico and back. He is survived by his wife of 59 years Anna Mae Botley; two children, Steve Botley of Cave Junction, OR, and Becky Blackshaw of New Zealand; and two grandchildren. A service will be held May 31 at 2 p.m. at Humboldt UU Fellowship in Bayside, CA. Messages may be sent to Anna Mae Botley.



Helen Hersey Dick, 89, died March 7 in Foxboro, MA. Her father was Universalist minister Harry Adams. She graduated from Jackson College (Tufts) and did graduate work at Crane. She gave leadership to the Girl Scouts, Cub Scouts, League of Women Voters, the NAACP, Food Co-ops, and to local UU churches where her husband, the Rev. Robert T. Dick, was the minister - Bristol NY; Lyons OH; West Hartford CT; Belpre OH; South Acton MA; Springfield and Chester Depot VT; Elkhart IN. Helen was an officer of the UU Peace Fellowship, and edited its newsletter. She served on the UURMAPA Board in charge of the Caring Network. In 1975, she was named Vermont Mother of the Year. Helen marched in Selma in 1965.

In 1986 the UU Church of Springfield VT, named her Minister Emerita. She accompanied the Springfield Community Chorus and taught piano. She is survived by her husband of 65 years; two sons, Nathan Dick of Estes Park CO; and Jeffrey Taft-Dick of Niger, West Africa; a daughter, Noreen Redd of San Diego CA; and three grandchildren. Robert T. Dick continues to reside at Doolittle Home.

**Reverend Thomas D. McMullen**, 76, died Feb. 26 in Tallahassee, FL. He was a graduate of Florida State University School of Music. He served in the Air Force as instructor of music theory and conductor of the Strategic Air Command Chorus. In Bradenton/Sarasota he was conductor, teacher of brass instruments, music store owner, and publisher. In midlife, he earned a D Min. at Meadville and served UU Churches in Studio City, CA; Plandome, NY; and Orlando, FL. He recently worked at the Florida Dept. of Elder Affairs. Family include his wife, Barbara Stansell; two sons, Tom McMullen of Tallahassee and Nathan McMullen of Nantucket, MA; and two grandchildren. A service was held March 17 at Goodwood Museum and Gardens, Tallahassee.

Reverend Keith C. Munson, 85, died Feb. 5 in Bradenton, FL. Marguerite (Peggy) Hanson Munson died Feb. 17 in Swampscott, MA, just 12 days after Keith, and a day before their 63rd wedding anniversary. Peggy had been suffering from Alzheimer's. Son Bruce writes, "We don't believe that she knew Dad had died. On the other hand, our Mom and Dad had been together for so long that perhaps somewhere deep inside Mom knew or felt that something drastic in their relationship had ended." Keith (and Peggy) served congregations in Annisquam, Palmer, Springfield, and Andover, MA; Cherry Hill, NJ; and Quincy, MA. Keith and Peggy hosted Gov. and Mrs. Michael Dukakis and the Adams family at the Bicentennial Celebration there in 1976. In 1983, Quincy awarded Keith a plaque for his services to the community. When he retired Keith was made an Honorary Citizen of Quincy and Minister Emeritus at the Quincy church. He was a

Board member of UURMAPA for eight years, and President for four. Avid sailors, the Munsons sailed from Maine to Florida and back again on Keith's beloved Galatea, a 36-foot Pearson Pilothouse. They were members of the UU Church of Saco and Biddeford, ME, and owned a house at Ferry Beach. Survivors include Carolyn (Lynn) Cashman of Cork, Ireland; a son, Bruce Munson, of Beverly, MA, and six grandchildren. A service will be held to honor Keith and Peggy in the early afternoon of August 3 at Ferry Beach in Saco. Messages of remembrance may be sent to Bruce Munson.



Reverend Dr. Frank E. Robertson, 76, died Feb. 6 in Plymouth, MA. Certified in Religious Education, he studied World Religions, specializing in East Indian studies. He studied and traveled in India in 1979, and Japan in 1984, then participated in the creation of a World Religions curriculum in 1987. After ordination by Grace Church in Lowell, MA, Mr. Robertson served in Barneveld and Shelter Rock, NY, and Paramus, NJ. He served as MRE in Washington, DC, Santa Barbara, CA, and Evanston, IL, where he was named Emeritus. Frank was a founding member of Interweave, to address Gay, Lesbian, Bisexual, and Transgender concerns. Through their efforts, General Assembly passed

resolutions concerning GLBT rights and the UUA Office of Bisexual, Gay, Lesbian, and Transgender Concerns was established. Frank was awarded an honorary D Div from Meadville Lombard. He received the Angus MacLean Award for religious education. He served on the Boards of the UUA and LREDA, St. Lawrence Foundation and IARF. He founded and chaired the UU Religious Education History Group. He was an Elder of the Mass. Society of Mayflower Descendants. He is survived by his partner of 36 years, Rick McDonald; two daughters, Lydia Robertson of Brooklyn, NY and Denene Ray of Charlotte, NC, and three granddaughters. His son, Joel, died in 1993. A service took place April 19.



*Wallace Reid*, 81, our UURMAPA Caring rep to the NJ-Metro District, died suddenly April 17. He served in the US Navy Medical Corps in World War II, and was a research chemist for Union Carbide from 1955-1985. He then served as a hospital addictions counselor until 1995. He was married to the Rev. Lee Reid, and a co-founder of the intentionally diverse UU Congregation of the Palisades in Englewood, NJ, in 1989. Eight years after they helped to found the church, Lee was hit by a car and killed in a tragic accident. After her death Wally remained on as an integral part of the congregation. He is survived by three daughters


Martha, Kate and Sarah Reid. There will be more information on the website www.uucpalisades.org.

**Reverend Martin Skewes-Cox**, 80, died in Sonoma, CA on March 16. He is survived by his three children: Peter of San Francisco, Thomas of Thousand Oaks, and Edith of Montreal, Quebec; and 11 grandchildren. A service celebrating his life will be held at St. John Episcopal Church, Ross, May 7, at 11am. In lieu of flowers, the family asks that donations be made to the Starr King School for the Ministry, Berkeley.

Reverend Carl F. Thitchener, 75, died Feb. 15 in Clifton Springs, NY. After a successful business career where he was a pioneer in the early microfilm information retrieval industry, he transitioned to ministry. He earned an M. Div. from Starr King in 1980 and was ordained at the First Unitarian Church in Rochester, NY, where he had been an active layperson for 20 years. He served the UU Church of Amherst in Williamsville, NY, starting in 1981. His wife, the Rev. Maureen Thitchener, joined him there as co-minister from 1991-2003, when they were honored as Ministers Emeriti. Carl also served congregations in Fairfax, VA; Rochester, NY; and Waterloo County, Ont. At the time of Carl's death, he and Maureen were coministers at the UU Church of Canandaigua, NY. Carl served as Secretary to the UUA Board of Trustees, and on the Boards of the Buffalo Area Metropolitan
