## What I Learned at the Northeast UURMAPA Conference in October by Dorothy Boroush

### **UUMA** Life Membership

In a letter to Charity Rowley, Janette Lallier, UUMA administrator, clarified requirements for life membership in the UUMA. Janette writes:

There are three requirements to be granted Life Membership in the UUMA.

- 1. You must be an active member of the UUMA.
- 2. You must have retired or announced your intent to retire.
- 3. You must request an upgrade in membership to Life Member

Therefore, while many, if not all, UUMA Life members are also members of UURMAPA, it does not follow that all UURMAPA Members are automatically UUMA Members. When a member receives Life Member status I send along contact information for UURMAPA. If there is a minister in UURMAPA who is not a life member of the UUMA and would like to be they can be in touch with me and I will happily discuss the options.

Regarding dues: There are no dues required to maintain a life membership. I am fond of saying that once someone has made it to Life Member - the have indeed already "paid their dues." That said, a portion of the UUMA Budget is dependent upon the contributions of our life members. Each year life members are asked to make a voluntary continuation. The suggested contribution is \$125, but any amount is gratefully received. It is my understanding that these contributions would be considered a donation by the IRS.

#### In Memoriam

*Virginia Bicknell*, widow of Kelsey died in July, 2007, and David Pohl conducted her memorial service at the Unitarian Memorial Church, Fairhaven, MA (where her late husband, Kelsey, was minister until his untimely death from cancer in 1976.) David writes, "Ginny was born in 1929, met Kelsey at St. Lawrence Theological School. and they were married in 1954. Virginia was a teacher as well as mother, grandmother and friend. Her children spoke of her as a great cook, one who loved puzzles, and had a boundless love for her family. She was also 'a second mother' to many college students. I shall always remember her as a smart and kind person who lived with courage and grace throughout her 78 years." She leaves a son, Michael, and three daughters, Rebecca Bicknell, Leigh Hemingway and Anita Langley.

Reverend Gene Bridges, 78, died Jan. 3, 2008, at his home in Honolulu, HI. A 1959 graduate of Starr King, he was ordained by the UU Association of Tacoma, WA, in 1960, serving there 3 years. He served the First Unitarian Church of Honolulu, HI from 1962-1970. He then returned to the practice of law, creating The Divorce Clinic to provide low cost legal assistance to persons of limited income. He also owned and operated Bed & Breakfast Honolulu (Statewide), the largest Bed and Breakfast association in Hawaii. According to The Rev Mike Young, Mr. Bridges was a stalwart supporter of civil rights, racial justice, and peace. The Hawaii ACLU's first phone was on his desk and he had marched in Selma. Surviving Mr. Bridges are his daughter, Beth Eileen Bridges; two sons, Adam and Channing Bridges; and four grandchildren. His wife, Mary Lee Tsuffis, predeceased him in 2003. A memorial service was held Jan. 13 at the First Unitarian Church of Honolulu. Messages may be sent to his children at 3242 Kaohinani Drive, Honolulu, HI 96817-1020.

Julia Cairns, widow of Fred Cairns, passed away Dec. 29, 2007. Her son Ken reported "She died peacefully at her home with her family around her. She was a great lady." Barbara McDonald Lewis, 76, died Oct. 18, 2003, in Portland, OR. Barbara was born in a logging camp in Marcola, OR, to a pioneer family who later moved to Salinas in Monterey County, CA. She fell in love with theater there. She married Navy Lt. James Ford Lewis in 1945. Ford became a UU minister; Barbara cotinued as a an actress and became a mother. From 1952 to 1970 Ford led churches in Riverside, Stockton, Portland, Oregon, and the UU Society in Sacramento. Barbara brought her acting and directing to the church stage, as a founder of Theater One. She produced countless shows, and plays written by fellow UUS, like Stuff as Dreams Are Made On by Rev. Ted Webb. Ford passed away in 1998 and Barbara returned to Portland to be closer to family, continuing acting there. She loved character parts. Barbara was active in UU Society activities and as a clerk for the Federal Courts. She is survived by James Ford Lewis, Jr., Bronwen Lee Gaderberg, and Mary McDonald-Lewis, 2510 NE Klickitat, Portland OR 9997212.

*Ibby Nagy*, has died in Calgary, AB. She was widow of Rev. Zoltan Nagy. Rev. Joe Bassett tells us Nagy was ordained in Kolosvar, Romania. He became a chaplain to Unitarians in the Romanian Army during WWII. When the army was impressed by the Nazis he was sent to the eastern front and was present during the Siege of Stalingrad. Ibby followed him there, disguised as a man, and pregnant. She miscarried the child. Returning from the Eastern front, they kept going into Germany, where Ibby was in forced labor making Nazi uniforms until Pattons' army came through and liberated them. While working in a camp for displaced persons, they adopted their daughter, Vera. Through Zoltan's work for the Unitarian Service Committee and Vilma Harrington, they eventually came to America. Zoltan served UU churches in Altoona, IL; Fairhaven, and Chestnut Hill, MA, where he died in 1969. Ibby eventually moved to Calgary to be near Vera. Ibby filled the role of minister's wife in a classic Eastern European style, and had a beautiful garden in Chestnut Hill. If anyone knows Vera's married name and address, please let Eleanor Richardson know, so she may publish it.
