More on hearing loss

Liz Benjamin writes, "About the hearing aid issue: I recommend to others that they do something (take gingko?) to upgrade their brain when they get hearing aids. Once you have them, it's true that fewer people mumble, but the hearing aids are small, and you have to keep track of them carefully. This is especially difficult in the summer. Last summer I kept leaving them at distant cottages where I had enjoyed a swim, and then I had to annoy someone and get that person to return them to me, if there were a phone at the cottage and I didn't have to drive back myself.

"I also do not recommend jumping into a lake wearing your hearing aids. If they do not fall out and disappear into the depths, they at the very least get soaked and therefore ruined. I speak from experience! People are mumbling again, until I can save

up enough money to get some more hearing aids."

Bob MacPherson writes, "Thanks for the contribution on hearing loss. From 1948 to 1966 I served five UU pulpits prior to merger of the Universalist Church of America and the American Unitarian Association. Wanting to enter a different branch of ministry, I took two graduate degrees in Audiology and Speech Pathology from Syracuse University. I applied to UUA for what is today called Community Ministry in 1967. I was turned down as no such program existed. I served as an audiologist and speech pathologist with the Veterans Administration (VA) Medical Program, 1967 to 1993. I started the program in Audiology and Speech Pathology at VA Medical Center in Asheville, NC, and developed a full range of diagnosis and treatment. I was recognized by the UUA for 50 years of service in Community Ministry, in 1999."

Bob continues: "Comment 1: Gradual loss of hearing has been described in much of the literature as a concomitant of aging. Twenty-six years of testing and treating veterans from one Spanish War veteran to Vietnam and Gulf War veterans made it possible to find more more specific causes of hearing loss as opposed to systemic, developmental. Patterns of hearing loss can be related to industrial noise, driving tanks in combat, small arms fire, and on and on. One veteran served in the national US Army band. His loss was relat-

ed to practicing in a small room with no sound treatment and 100 plus instruments band.

"Comment 2: Going in for a free test may be a start, but may I suggest that one could save much time and find much more information by seeking out a professional audiologist?

"Audiology has moved from a masters program to a degree of Doctor of Audiology. These professionals practice commonly with Ear Nose and Throat (ENT) Specialists or at community hospitals and VA medical centers. Some now practice independently. Tests can determine or rule out many different causes. Treatments can vary. Hearing aid sales offices have people qualified sometimes as engineers but may or may not be interested in referring to surgeons. Please look in your phone book and find 'Audiology' and a practitioner with an AuD degree!"



Charles Eddis has just published Stephen Fritchman: The American Unitarians and Communism -A History with Documents. He says, "It is as researched a study of the Fritchman Affair of 1946-47 and the related communist control of the USC in Europe 1944-47 as will likely ever be done, unless the AUA releases secret files they are rumoured to have on the subject." His study includes FBI internal reports believed to have been destroyed and only published in 2007, and private matters only delivered to archives in the last year, which old AUA files will not have. He doubts such files exist, though records of the 1946 hearings of the AUA executive committee into the charges that Fritchman was abusing his offices of AUA Director of Youth Activities and as editor of *The Christian* Register may still exist, he doubts they will have anything his book does not. His book includes much about the hearings. There is an autobiographical note to the book, since he was heavily involved from 1946, and discussed the whole matter briefly with Donald Harrington as recently as his last time at the UURMaPA gathering in Attleboro in about 2000. They had a long association. The book is full of the key people in its three stories: the AUA, Fritchman, and the USC. There is a large table of contents so such people are easily found. It gives an inside view of how the whole drama played out. What it was all about was never researched. It was like a repressed memory, ignored after the initial aftermath, but not quite forgotten, just smoothed over. Fritchman was elevated to sainthood, receiving the UUA Annual Award for Distinguished Service to the Cause of Liberal Religion in 1976. He merited it. But no one in recent time has seemed fully aware of what he was up to from 1940 to 1947. Those who objected to what he was doing then have been labelled McCarthyites by those later writing our history. Charles says, "This book was undertaken to set the record straight." and active in various other civic groups. He had a particular interest in lakes and conservation. Herb loved to go to Heald Pond, his summer home of 42 years, in Maine. He also enjoyed golf, fishing, poker, theater and jazz. Most of all, he relished spending time with his extensive extended family. He is survived by Mary Ryan Adams, his wife of 34 years; his sister Anne Adams; his four children: Ashley, Joshua, Lee and Rachel Adams; three stepchildren, 12 grandchildren; and five nieces and nephews.



The Rev. Dr. James D. Hunt. 79, died January 12, 2011. He was a graduate of Tufts, Boston and Syracuse Universities. His first career was as a Universalist minister. The parts of being a minister he liked the best were studying and preach-

ing. This led him to pursue a second career in teaching. He was a professor of ethics and religion at Shaw University, Raleigh, NC for nearly 30 years. His first major publication was a comparison of the lives of Martin Luther King and Mohandas K. Gandhi. He went on to write about the early life of Gandhi, an interest which culminated in the publication of four books. Jim had a passion for fairness and justice. He worked with Amnesty International, ACLU, Witness for Peace, Peace Action, CITCA, People of Faith Against the Death Penalty, and CORE. A devoted family man, Jim found time to enjoy cycling, reading, hiking, folk dancing, playing the recorder, singing and traveling. He is survived by his wife, Jane. his children, their partners and grandchildren.

Doris McBride Kellison, 94, widow of the Rev. Walter E. Kellison, died February 19, 2011. The Kellisons served congregations in ME, MI and IA while they reared three children. A graduate of the Rochester Business Institute, Doris used her secretarial skills, first doing church work and then transcribing medical records. She went on to become the secretary for an internal medical practice for many years. She was a reader, who enjoyed good conversation. She also loved to walk. She liked to cook and was an avid recipe collector. She enjoyed growing basil and parsley in her garden to add her own touch to meals. Late in life she took up doing crosswords and double crostics. She was predeceased by her husband and by her daughter, Judith. She is survived by her children, Walter and Kathy, her daughter-in-law, two granddaughters and a great granddaughter.

After retiring in 1992 she served the Lynchburg, VA congregation part-time for six years. She served on the governing board of the UUUN Office, Collegium and UUs for Social Justice. She is survived by her twins: Christopher (Kit) and Catherine Perin Knowles, of Tucson. She was predeceased by her son, Jeffrey.



Isabel Paine Niles, 90, widow of the Rev. Albert C. Niles, died November 9, 2010. She attended St. Lawrence University for two years. After her marriage, she coordinated and taught in the Sunday schools at the Universalist churches in South Wey-

Making a difference



A couple of years ago a member of First Unitarian Albuquerque and I began to form the New Mexico UU Legislative Network in order to better inform New Mexico UU's about state legislation and to influence our representatives on issues that align with our values. Our first task was to enlist liaisons from the ten NM congregations plus the three branches of First U. To date, we have liaisons in the five churches that have professional ministry, plus two other UU communities.

Our legislature meets once a year, odd-numbered years for 60 days and even-numbered years for 30 days. So this year was a 60-day session and for many of us, it was a time to "cut our teeth." We traveled to Santa Fe to meet our legislators face-to-face and take a peek under the roof of the State House. We called and emailed on legislation we felt to be pertinent to us as UU's.

My job was to inform the liaisons of pending action and ask them to spread the word to their congregations. They, in turn, acted in a variety of ways. They set up tables on Sundays to display legislative information and to provide district maps. They also used the internet extensively.

Of particular interest in this year's session were bills on immigrant rights, funds for early childhood education, and the budget itself. New Mexico is required by law to have a balanced budget each year. We began the year approximately \$200 million in the hole. We also have a new Governor who wants to rid the state of immigrants by denying them drivers' licenses and access to higher education scholarships; she also tried to reinstate the death penalty, which had been rescinded several years ago. As you can imagine, our work was cut out for us.

The session ended March 19. After that we took a little time to draw our breaths and then reactivate ourselves to strengthen our Network. My hat goes off to a wonderful team of liaisons and the work they've done to make New Mexico UU's better informed on state issues.
