### THE STAGES OF RETIREMENT: GO GO – SLOW GO – NO GO

I don't know who coined the phrase describing three stages of retirement, but they are clearly provocative.

There is the potential burst of energy when one leaves the pulpit in a settled or interim ministry for the last time. While I had to choke back the tears in June of 2002 when I left the Rochester Unitarian Church, I

felt that I still had a great deal of ministry left in me. Even after three years of interim work I discovered that while you can take the preacher out of formal ministry, it is hard to take the ministry out of the preacher. Even now, eleven years from 2002 and eight from the end of interim work, I like to be in the pulpit, give workshops and be there for special memorial services. I suspect many of you share this perspective. We don't really want the burdens and responsibilities of full – or even part-time – work, but the itch is there and we still have the energy to scratch it. Of course, there are also those among us who turn their talents and energies to non-ministerial pursuits, hobbies and interests to which they can give real attention perhaps for the first time.

Then, there is the "slow go" of retirement, occasioned by the inevitabilities of simple aging or perhaps an illness or an operation. As I recover from another hip replacement, I am anxious that the recuperation period will slow me down to the point of frustration. I hope to exhibit what I have called "the courage of patience" as I enter a period of harnessing my gait and being more dependent on others. (Ministers, I find, don't like being dependent – we are good at serving – not so good at being served). This is a difficult stage of retirement.

Finally, we enter the "no go" stage when our energies are consumed just getting through the day and the night. These are the frustrating years when we seem to have nothing more to give. Here "doing" gives way to "being," with its considerable challenges. I have phrased the question "what are we worth when motionless?" as topic for a future column.

As I am in touch with many UURMaPAns, it strikes me that many of us move back and forth through these stages, waxing and waning as health and mortality become central issues. Probably most, if not all of us, will touch each stage. Some of us hope to remain in the "go go" stage to the very end and go out like a quickly extinguished candle. Others of us will be content to move through each stage in succession. How we deal with each will be our contribution to those who follow. We are the models for our colleagues. May we negotiate each of these stages with grace.

#### **Dental Care in Retirement**

The UUA Office of Church Staff Finances recently announced that as of January 1, 2013, newly retiring ministers and church staff who are at least age 62 and already enrolled in the UUA dental insurance plan can continue their participation in the plan during their retirement. That's good news for UURMaPA members-to-be, assuming they want to continue their dental insurance. For UURMaPA members-in-fact, however, according to Jim Sargent, UUA Health Plan Director, no such participation is or will be available.

This doesn't mean that retired persons can't find dental insurance. AARP offers a dental insurance plan to its members. Many AAA regional offices do, too. Google "dental insurance for seniors." Reading the fine print, however, you are likely to find that the premiums are higher, the benefits fewer, and the exclusions more tightly drawn than in the UUA plan.

### **Affordable Care Act**

There will be an enormous amount of information about the impact of the Affordable Care Act (ACA) in the next year. The complete first issue of the UUA's fine new monthly "Alert" prints out at 6 pp. The "Executive Summary," however, is only 1 page. Because the Affordable Care Act has nothing to do with Medicare, the great majority of retired colleagues will not be affected by the ACA.

#### **UURMaPA Survey Summary**

The decision to survey members resulted from ongoing discussions by the UURMaPA Board about how our members were faring financially, how well our Caring Network is functioning, and how our members feel about attending conferences or other gatherings. The UUA Office of Church and Staff Finances also requested member organizations to poll their members about the UUA's Health Plan. We also feel it is important to have emergency contact information for our members. All these issues were put into one questionnaire that was mailed to our membership. This is the (long overdue) report of those results.

Of the 597 surveys mailed in June 2012, 242 completed ones were returned, a reply rate of 40.5%. Of those, 76% said that they are all right and expect to be so in the future. Sixty-three respondents (26%) had some concern about their finances. For some, even by reducing living expenses, they feel they will not have adequate resources in the future, or are in need of help now.

Regarding the UUA Health Plan, only two respondents are members of that plan and neither saw a need to change the benefits. Of those who answered these survey questions, 91 were satisfied with their current plan; 28 felt the plan cost too much; some didn't know about the plan (many of our members retired prior to its existence); eight widows of UU ministers didn't know they were eligible. It is apparent that at this time the UUA Health Plan is not an issue for most of our members, but there is also the need to make members aware of it as an option.

Some members feel they cannot afford dental care, and a few said they were unable

to get a prescription filled within the last year because of finances. This was discussed by the Board with Joyce Stewart of the UUA Office of Church and Staff Finances in September. One of our Board members is liaison to the Council on Church Staff Finances and has presented our concerns.

Regarding attendance at conferences, UUMA Chapter Meetings, or other gatherings, some respondents skipped the question, some said they attend sporadically. Others frequently attend. Reasons for not attending included health/age/accessibility cost or difficulty of traveling, busy with other interests, "UUMA Chapter Meeting programs are for active ministers," or just "not interested." Anecdotal experience suggests that the longer ministers and partners are retired, the more their interests shift from church or UUA-related activities to other, often more local pastimes.

The returned surveys were given to the Caring Network Coordinator to follow up on any pastoral need expressed in them. The survey also requested Emergency Contact information; 210 members provided this, which will be kept on a database for possible pastoral concerns. UURMaPA now has emergency contact for 35% of our households. ### **How Would You like to be Remembered?**

Alfred Nobel, Swedish chemist and industrialist, had the life-changing experience of reading his own obituary. His brother died, but a Paris newspaper mistakenly reported the death of the "dynamite king." So Nobel awoke to find his life laid out on the front page of his morning paper. The shock was overwhelming and life-changing. He saw himself portrayed as a weapons dealer, trading in death and destruction. Nobel had a kinder view of himself. He understood the purpose of his life to be bringing different people together, breaking down barriers between diverse nations and people. He resolved to make clear the true purpose of his life. He devised the plan for disposition of his fortune so that it might support individuals and groups effective in working for understanding and peace. The Nobel Peace Prizes were born from a mistaken obituary.

Still Alice by Amy Genova -- book recommendation by Chris Lilly Backus.

As we grow older, we may fear that our minds are slipping. Perhaps this fear is why I listened so intently to a book review on NPR a few years ago about Amy Genova's nicely-crafted novel *Still Alice*. I just got it out of the library and found it very compelling. The main character, Alice, a brilliant Harvard professor, begins to lose track of things she had known well. She is painstakingly diagnosed with early onset (younger than 65) Alzheimer's disease. The book is written from Alice's viewpoint, which I found very touching and poetic.
