UURMaPA's Unsung Hero Award

The UURMAPA Board of Directors has instituted a new Unsung Hero Award to be given to one of our UURMAPA members who has not been recognized for his or her vital contributions to our UU retired movement along with generous service to others. This award will not replace the Creative Sageing Award (which we will do next year) but is an extra plus for service deserving of recognition. It is proposed that each year the UURMaPA Board will call for nominees from the membership to honor a volunteer who has made an extraordinary contribution to our association, working behind the scenes during their retirement years. The successful nominee will not have been recognized elsewhere. The honoree will be recognized at General Assembly or at our UURMAPA Fall Conference, in *Elderberries*, and will receive a \$500 honorarium. This year, for the first recipient, we would like to place before you the name of the **Rev. Glen Snowden** for the Unsung UURMAPA Hero Award. Glen is a former member of the UURMAPA Board and took on the role of Coordinator of the Caring Network Reps all across the Continent. I know of his work because he persuaded me to take on the position of Caring Representative for the Ballou Channing District. It was my job to keep in touch with retired UU ministers and their partners and report back to him on any needs or concerns that came my way. Glen also worked on the Planning Committee for the Attleboro Fall Conference for a number of years

I have direct knowledge of his able work in this area as well because he got me to serve on that Committee with him. How do you say No to a sweet talking guy like Glen when all he wants you to do is assist him in his wish to be of help and service to his fellow ministerial colleagues and their partners?

Glen may be soft spoken, but he's very persuasive in a very caring way, because he really cares and he really means it when he sets out to be of help and service to others or asks you to join him in that service. I can also testify that Glen Snowden is the kind of guy who hangs in there for the long term, loyal to the end. He did it with his late beloved wife Lorraine, and he did it in so many other tasks and obligations he took on over the years. For example, Glen has been Secretary of the Society for Ministerial Relief at least since 1980. David Pohl says that Glen was there when he went on in 1973. People who have dealt with Glen on personal financial issues have uniformly said that he was most kind and gracious and professional in helping them. Many retired ministers are indebted to Glen - not for the money they received since that came from the Society- but for his assistance in helping them organize their finances to present their case for help. He has always been diligent and timely in his response to people in need.

Continued from Page 1: For many years Glen was Secretary of the Unitarian Service Pension Society, and still continues to serve as one of its Directors. This is an investment group that manages and distributes quarterly contributions to retired ministers who have served for 20 or more years. If that were not enough Glen also serves on the Board of the Massachusetts Congregational Charitable Society since at least 1990 – an organization with both Congregational and Unitarian roots that provides charitable help and aid to needy clergy and their family within our Congregational and Unitarian churches. I don't know where Glen finds these groups but I'm glad he's there "doing the Lord's work."

I've known Glen since 1970s and 80s when he asked me to speak to one of his religion classes at Emerson College (where he was a teacher and professor) about parapsychology and mystical experience. He and I worked together on the Psi Symposium Board for some 30 to 40 years trying to promote interest in psychic and mystical experience within the UUA. I told you Glen had the propensity to hang in there for the long term. I'm just glad he's hung around long enough to be part of our UU Retired Ma Pa organization and just in time to receive this first and well-deserved Un-sung UURMAPA Hero Award. *Dick Fewkes*

Learning to Age Gracefully and Gratefully Richard S. Gilbert, UURMAPA President

My wife Joyce and I do a fair amount of child care with our grandchildren. A 6 a.m. phone call more often than not brings news of a sick grandchild (we have three in town – ages three, six and nine). Both our younger son and his wife work in jobs where substitutes are not easy – he is a middle-school history teacher and she is an occupational therapy supervisor. Usually we do a "tag team" so one of us is available for the necessary coverage. We enjoy being helpful and we get to know our grandchildren well; that is one of the reasons we remain in Rochester.

Moreover, this responsibility is a learning opportunity. Take what I have learned from our going-on-ten grandson, Sam, for example. We had taken all three of them to a library playground for an after-school stint. I was playing tag with the three of them, rather unsuccessfully chasing them around the playground. Of course, I was almost always "it." Other children on the playground joined in the fun. One of them shouted a warning to Sam: "Watch out, he (referring to me) will catch you!" Sam stood there a few feet from me smiling, arms confidently crossed, and said, "He's my grandfather. I can easily outrun him!" And, of course, he was right. A 70-something with arthritis is no match for a very athletic boy. That didn't make it any easier to take, however. I fancied myself an athlete in my younger days – football, basketball, baseball, tennis, etc. I didn't know quite how to respond to Sam – with an embarrassed admission he was right, or pride in the athletic prowess of a boy who has some of my genes.

A few weeks later the same scene played out on a soccer field one Saturday morning during warm-ups for a youth program. I challenged him to dribble the ball past me and squared myself for the assault. He came at me with speed and deception, sending me solidly on my posterior in the wet dew. I had to laugh at myself.

So it goes that our grandchildren are teaching me to age gracefully. My increasing limitations are balanced by my pride and joy in their increasing capacity. I'm coming to admit that I just can't do what I used to do, though I have stubbornly fought to do so. I hope they appreciate that I keep trying to keep up with them. And I try to stay in shape – if only to enjoy long hikes, brisk swims and hide-and-seek with them.

I find it a challenge to age gracefully, but try I must. It helps to remember that I was once like that nearly 10-year-old grandson. It helps to remember how grateful I have been to enjoy the sheer bodily energy of sports. And it helps to be grateful for what has been, and for the generations unfolding before my appreciative eyes. Growing older is not for wimps, for sure. There are compensations, however. And one of them is a red-haired grandson who knows he can easily outrun you.

STEVEN C. REINHARTSEN (1951-2012)

Reverend Steven C. Reinhartsen died, unexpectedly, at home on September 14, 2012. He was 61 years old.

Rev. Reinhartsen was born in Amityville, NY on June 7, 1951. He attained his Bachelor of Science degree from Valparaiso University in 1973. In 1981, he went on to earn a Master of Education from the University of North Carolina, Greensboro. Finally, in 1997, he earned a Master of Divinity from Duke University.

Rev. Reinhartsen was ordained on January 12, 2003 at the Unitarian Universalist Church of Greensboro, NC. A community minister, he spent over two decades as a career counselor to students at Alamance Community College. Recruited by a small group of Unitarian Universalist residents to help form the UU Fellowship of Twin Lakes in January 2000, he also provided spiritual leadership and preaching to the Unitarian Universalist group at Twin Lakes Retirement Center in Elon, NC.

Rev. Reinhartsen's life experiences were vast, including years of travel and adventure. During and after college, he hitchhiked across the U.S. twice; studied for a semester in Germany; and spend two years teaching in Australia. He and his wife, Mary travelled extensively throughout their years together. They visited nearly every major national park, and also travelled to places such as Paris, London, Santa Fe, Costa Rica, Niagara Falls, Toronto, Montreal and Vancouver. Rev. Reinhartsen enjoyed jogging, hiking, golfing, landscaping, fantasy baseball, and a good bottle of red wine. Described as a "quiet, wise, kind man," he made those that knew him "feel at ease from the beginning" with his "calm nature." A friend noted, "Steve was such a thoughtful person and so many people will always remember him for that."

Rev. Reinhartsen is survived by his wife, Mary Davis; a son, Karl Reinhartsen; a brother, Paul Reinhartsen; a brother, Lars and his wife Gretchen Reinhartsen; as well as nieces Rois, Maja, and Zoe.

A memorial service was held on Tuesday, September 18, 2012 at the Unitarian Universalist Church of Greensboro in Jamestown, NC.

As many of his friends, colleagues and family knew, Rev. Reinhartsen was passionate about the work-study program at Alamance Community College and how beneficial it was for students to hone their skills before entering the workforce. In honor of this legacy of passionate advocacy for students, the College has created the Steven Reinhartsen Memorial Scholarship. This scholarship will benefit work-study students at ACC and help with tuition, books and emergency expenses. JOHN F. "JACK" HAYWARD (1918-2012)

UURMaPA joins the Ministries and Faith Development staff as we offer our condolences to the family and colleagues of the Rev. Dr. John F. "Jack" Hayward who died on September 24, 2012. He was 94 years old.

Rev. Hayward was born in Winthrop, MA on May 8, 1918 to Catherine and Frank Hayward. He graduated with an A.B. from Harvard University in 1940. He went on to attain a B.D. from Meadville Theological School in 1943 and a Ph.D. from the University of Chicago Divinity School in 1949. Finally, in 1968, he earned a D.D. from Meadville Lombard Theological School.

Rev. Hayward was ordained on June 10, 1943. He served as a military chaplain in the United States Naval Reserve and later, in the Marines, from 1943-1946. He was called to serve as minister of the First Unitarian Church in Columbus, OH from 1948-1951. He then began his career in higher education at the University of Chicago, serving as an Assistant Professor of Religion and Art from 1951-1956 and as an Assistant Professor of Philosophical Theology from 1956-1961. He went on to work as an Associate Professor of Theology at Meadville Lombard Theological School from 1961-1968. In the years spanning 1968-1983, he served as the Chair of the Department of Religious Study at Southern Illinois University. He retired in 1983.

Rev. Hayward was a proud, founding member of Prairie Group. He served as the Scribe for over 20 years, and received Emeritus status from them upon his retirement from the group after 54 years.

Rev. Hayward is survived by his loving wife, Lois Hayward; daughter, Miriam Hayward and her husband, Rick Herbert; son, David Goodward and his wife, Margaret; grandchildren, Megan Hayward, Zachary Hayward, Joseph Herbert, Gina Hayward, Gavin Goodward, and Jenna Goodward; and great-grandson, Jaden. He was predeceased by his sons, Peter Hayward and Steven Hayward; and his beloved first wife, Muriel Sternglanz Hayward.

JOHN "JACK" WILKINSON, III (1928-2012)

UURMaPA joins the Ministries and Faith Development staff as we offer our condolences to the family and colleagues of the Rev. John "Jack" Wilkinson, III who died on October 22, 2012 at the age of 84.

Rev. Wilkinson was born in Syracuse, NY on July 24, 1928 to Mary Leavenworth (Van Duyn) Wilkinson and John Wilkinson, Jr. He attained his Bachelor of Arts degree from the University of Miami in 1951. He enlisted in the U.S. Army and served during the Korean War. Later, in 1964, he received a Bachelor of Divinity from St. Lawrence University Theological School.

Rev. Wilkinson was called to the Second Universalist Church of Weymouth, MA in 1964 (where he was also ordained on October 11, 1964) and served as the minister there until 1968. He was then called to the Unitarian Universalist Church in Chattanooga, TN from 1968-1976. Lastly, he served as interim minister at St. Paul's Universalist Church in Little Falls, NY from 1989-1990. He retired from the ministry in 1990.

Rev. Wilkinson denominational activities included his work in 1965 on the Family Summer Institute Planning Committee in Ferry Beach, NH; his position as Chairman of the Religious Arts Committee for the Ballou-Channing District from; his work as an advisor to the Liberal Religious Youth Spring Conference in Lynn, MA; the position of Chairman of the Arts Committee for the Thomas Jefferson District from; and as Treasurer of the Southeast Unitarian Universalist Ministers Association from. He also participated in the historic civil rights march from Selma to Montgomery, AL.

Rev. Wilkinson was a social activist who made a sincere investment in his communities by serving as President of the Chattanooga chapter of the American Civil Liberties Union; as a board member, member of the Executive Committee, and Treasurer of the Tennessee Civil Liberties Union; and as a member of the Religious Committee of the Chattanooga Bicentennial Commission.

A memorial service took place on Saturday, November 3, 2012 at the Unitarian Fellowship of Huntington, Huntington, WV 25701.

MAGGIE PIPES (1926-2012)

The Board of the Unitarian Universalist Retired Ministers and Partners Association joins with the family and friends of Maggie Pipes in celebrating her long and fruitful life. Maggie, the beloved wife was retired UU minister Ernie Pipes, died on May 24, 2012 after a very active 85 years. This summary of her life is taken from a beautiful tribute to her, written by Ernie and delivered at the celebration of her life held on June 30th, which would have been their 63rd wedding anniversary.

Maggie grew up in a small town in Texas near the Mexican border. She was bi-lingual, owned a horse, and was loved by parents who helped her develop a strong sense of self and confidence. She graduated from Trinity University with a major in Theater Arts. Her social concerns and liberal outlook took her to the Unitarian Church of San Antonio where she was active in local politics and justice issues; it was there that she met Ernie, whom she married on June 30, 1949. After Ernie's graduate work at Harvard, he was called to his first pastorate in Albany, NY. Maggie immediately became involved in the Montgomery Bus Boycott, with an intense commitment to the civil rights movement.

Maggie and Ernie raised three children, moving to Santa Monica in 1956, where she continued her dedication to social action. In the 1960s, in response to the urban crisis in LA, she helped create the Mafundi Institute, a center in Watts which taught film making, drama, dance and writing. In 1973 Maggie began to work with Cesar Chavez, representing the UUA to the National Farm Workers Ministry and, with Howard Matson, helped establish the UU Ministry to Migrant Farm Workers. Her work on their behalf extended over three decades.

Maggie was also instrumental in the Sanctuary Movement of the 1980s, which rescued Central Americans fleeing death squads, torture, and political repression. She inspired the Santa Monica congregation to sponsor a family from Guatemala, raising the bond money to move them out of INS detention and guide them through the process to win legal status.

Outraged by the assassination of Archbishop Oscar Romero of El Salvador, Maggie helped to create the Oscar Romero Spanish-speaking UU congregation at First Unitarian Church in LA, which has been active since 1982.

The riots following the Rodney King beating and trial in 1992 were in the vicinity of the First Unitarian Church. The Rev. Linnea Pearson turned to Maggie to form the UU Crisis Response Network, which became the Urban Ministry, serving the inner city through numerous community programs. Maggie served as chair from its inception in 1997.

In recognition for her many years of unheralded service in the cause of social action and liberal values, in 2002 Maggie was awarded the Unsung UU Award by the UU Association. As her health deteriorated Maggie still "worked the telephone" on issues and causes of concern to her and maintained a network of close connections with a large group of friends. What friends and family remember most about Maggie is the warmth and love which she brought to her relationships, and they were graced to have known this beautiful person.

CHARLOTTE JUSTICE SALESKA (1935-2012)

The Board of the Unitarian Universalist Retired Ministers and Partners Association joins with the family and friends of the Rev. Charlotte Justice Saleska who died on December 28, 2012 at the age of 77.

She was the first and only female settled minister of the Unitarian Universalist Church of the Quad-Cities, in Davenport, Iowa, from 1988-2000. She is survived by her sisters, Carol Jones and Carmen Wilks; brothers, Warren Justice and Sam Justice; son, Scott Saleska, his wife, Kirsten Engel and their daughter, Helene; son, Kent Saleska, his wife, Heidi Saleska, and their children, Parker and Mirek. A memorial service will be held in Spring 2013 on a date yet to be decided.

JACK MENDELSON (1918-2012)

UURMaPA joins the Ministries and Faith Development staff as we offer our condolences to the family of the Rev. Dr. Jack Mendelsohn who died on October 11, 2012 at the age of 94.

Rev. Mendelsohn was born in Cambridge, MA on July 22, 1918 to Jack and Anna (Torrey) Mendelsohn. Rev. Mendelsohn attained his Bachelor of Arts degree from Boston University in 1939. He then went on to earn a Bachelor of Sacred Theology from Harvard Divinity School in 1945. He received an honorary Doctor of Divinity from Meadville Lombard Theological School in 1962. Rev. Mendelsohn was ordained by the Beverly Unitarian Church in Chicago, IL on October 28, 1945. He was called to the Unitarian Church in Rockford IL and served there from 1946-1954. He then went on to serve the All Souls Unitarian Church in Indianapolis, IN from 1954-1959. Rev. Mendelsohn was called to the Arlington Street Church in Boston, MA and served there from 1959-1969. The years 1969-1978 found him working at the First Unitarian Society of Chicago until he moved his ministry to the First Parish in Bedford, MA where he served from 1979-1988. Rev. Mendelsohn retired and began his next career as an interim minister at the Unitarian Society of Santa Barbara. He served there from 1990-1991, and then found himself back in the northeastern United States at the Community Church of Boston, where he served from 1991-1993. He served as an interim minister from 1993-1994, and for the last time, at the First Parish Church in Beverly, MA. In 1988, he was named Minister Emeritus of the First Parish in Bedford.

Rev. Mendelsohn's lifetime of community activities and accomplishments were vast and impressive. He served as president of the following: the Urban League of Greater Boston, Boston's Foundation for Housing Innovations, the Binder Schweitzer Foundation, Hyde Park and Kenwood Council of Churches and Synagogues, Chicago's Alliance to End Repression, and the Abraham Lincoln Centre. He was the president and CEO of the Civil Rights Project, Inc.; and the grant administrator of Eyes On The Prize, an award

winning public television series on the civil rights movement. He served as director of the following: the Housing and Planning Association of Metropolitan Boston, the International Institute of Boston, and Chicago's Center for Psychotherapy and Religion.

Heavily invested in and committed to the denomination, Rev. Mendelsohn served as: a member and an officer of the Board of Directors for the Western Unitarian Conference; vice-president of the Unitarian Universalist Service Committee; chairman of the board of Beacon Press; vice-chairman of the Unitarian Universalist Black Affairs Council; chairman of the UUA's Program-Committee; chair of the UUA's Channing Bicentennial Celebration Committee; chair of the UUA Committee on Urban Concerns and Ministry; and president of the Unitarian Universalist Ministers Association (UUMA). He was also once a candidate for the presidency of the UUA; a founding member of the Association for Liberal Religious Studies (Collegium); a consultant for the Cambridge Forum; the only male member of the UUA Committee on Women and Religion; and an adjunct faculty member at Meadville Lombard Theological School. In 1997, he received the UUA Distinguished Service Award.

Long active in civil rights and political matters, Rev. Mendelsohn made headlines when he conducted the Vietnam War Resistance service at Arlington Street Church in Boston in 1967. He also served as an advisor on religious questions to his friend and fellow UU, Adlai Stevenson; and, in 1968, he served on the campaign staff of Robert F. Kennedy. In 1979, an old friend and colleague, the Rev. Jesse Jackson, asked Rev. Mendelsohn to accompany him on his trip to the Middle East to meet with Yasser Arafat. 15 years later in 1984, he once again travelled with Rev. Jackson to Syria to attend negotiation talks with Syrian President Hafez Assad.

Rev. Mendelsohn is survived by his loving wife, Judith Frediani; son, Channing Mendelsohn; daughter, Deborah Mendelsohn; son, Kurt Mendelsohn; granddaughters, Olivia Jenkins and Hannah Kossow; step-son, Aaron Worth; step-daughter, Keilah Worth; and step-grandson, Luca Domingos-Worth.

By-Law **Changes**

BYLAWS
OF
UNITARIAN UNIVERSALIST RETIRED MINISTERS
AND
PARTNERS ASSOCIATION
ADOPTED September, 2010

Article I - NAME

The name of this organization shall be Unitarian Universalist Retired Ministers and Partners Association.

Article II - PURPOSE

Acting in conformity with the purposes and principles of the Unitarian Universalist Association, the purposes of this organization shall be to serve the Unitarian Universalist movement, and to enhance the well-being of retired Unitarian Universalist ministers, their life partners and surviving life partners and to provide such programs and activities as may be feasible for their benefit.

Article III - MEMBERSHIP

All ministers in fellowship with the UUA **classified by the Association as retired** who have formally announced their intention to retire, their life partners, and the life partners of deceased Unitarian Universalist ministers, as well as all ministers granted life membership by the UUMA and their life partners shall be members of this organization. Other persons may become members by application to, and approval by, a majority of the Board

Article IV - ADMINISTRATION

Section 1 The Board of this organization shall be a President, a Vice President, a Secretary, a Treasurer, a Newsletter Editor, and a Caring Network Chair. and **twothree** Members-at-large.

Section 2 The President shall preside at all meetings of the Board and shall have general supervision over the activities of the organization.

Section 3 The Vice President, in the absence of the President, or in the inability of the President to serve, shall assume the duties of the President. In the event of the resignation or death of the President, the Vice President shall assume the office of the President for the remainder of the term.

Section 4 The Secretary shall keep a record of the proceedings of all meetings of the Board and shall perform such other duties as may be assigned by the Board.

Section 5 The Treasurer shall keep a faithful account of the financial transactions of the organization and shall receive contributions of funds and shall make payments in accordance with the policies and procedures adopted by the Board. Whenever the Board shall authorize the Treasurer to open an account at any bank or other financial institutions, the Secretary and other officers are authorized to execute such agreements as are usual for the opening and maintaining of such accounts without further action by the Board.

Section 6 The Newsletter Editor shall edit and supervise the production of a newsletter under the general direction of the Board.

Section 7 The Board shall administer the affairs of this organization and shall adopt policies and administer programs to carry out the purposes as stated in Article II.

Section 8 The Board shall send to all members, at least once every two years, a report of its activities including a financial statement.

Section 9 Meetings of the Board shall be held at least two times a year.

Section 10 The Board shall have the power to fill, for the remainder of the term, any vacancy that occurs in its membership or in the Nominating Committee.

By-Law Changes from page Ten:

Article V - ELECTIONS

Section 1 The officers, ~~two~~~~three~~ Members-at-large, and a Nominating Committee, consisting of a chair and two others, shall be elected by a mail ballot of the members.

The President, the Vice President, the Caring Network Chair, ~~one~~~~two~~ Members-at-large, and the Chair of the Nominating Committee, shall be elected in odd-numbered years.

The Secretary, the Treasurer, the Newsletter Editor, one Member-at-large, and two members of the Nominating Committee, shall be elected in even-numbered years.

Electees shall assume office on July 1 following their election and shall serve for two years. If, however, their successors have not been elected by the end of their terms, they shall continue in office until their successors have been qualified.

No officer, member-at-large, or member of the Nominating Committee shall serve more than two full terms in any one position. No person shall serve on the Board for more than six consecutive years.

Section 2 All members shall be eligible to vote in an election conducted by the nominating committee.

Before December 1 preceding the election, the Nominating committee shall poll the membership for suggestions of nominees. From these and their own suggestions, the committee shall make its nominations and notify the membership by ~~March~~~~April~~ **1**.

In case of multiple nominations for a single position, the Nominating Committee shall conduct an election by ballot to be completed in time for the election results to be certified by the Secretary and announced to the membership by ~~June~~~~July~~ **1**.

If only one person is nominated for each position, the person shall be declared elected.

No nominee shall be listed on the ballot without his or her consent. The Nominating Committee is authorized to establish such procedures as are necessary to carry out these provisions.

ARTICLE VI -AMENDMENTS

These bylaws may be amended by a majority vote of the Board in the following manner: the Board proposes an amendment; it is circulated to the membership so that members can send comments and/or corrections to the Secretary; an official Board vote will be taken on the amendment no sooner than 30 days after it is published.

UURMAPA BOARD PROPOSES A BY-LAW CHANGE

At its September/October meeting in Boston the UURMAPA Board voted to amend the by-laws by adding one member to the current membership of eight. According to our By-laws the Board proposes amendments which must be circulated to the membership (via Elderberries) for comment. The official board vote is taken on the amendment no sooner than 30 days after it is published. See the UURMAPA By-laws at www.UURMAPA.org.

The rationale for this proposal is the increasing work load of the all-volunteer Board. Its work is divided as follows: president, vice-president (GA liaison), secretary, treasurer, caring network coordinator, Elderberries editor, conferences coordinator, and a member at large. Our hope is to assign the member-at-large to assist the caring network coordinator in their ever-increasing work; and to add a member to work with UUMA on the proposals made by the UUMA Task Force on Retirement.
