LIFE AFTER MINISTRY

Dorothy Fisher wrote to the Editor, recounting a number of occasions which were satisfying and significant to her and Jack.

One was participating in the Global Vision 2000 Conference, a part of the 1993 Centenary Celebration of Swami Vivekananda's Universal Vedantic Message. It was held at the Hilton Hotel in Washington, D.C., August 6-8, 1993. A letter received by the Fishers described it in these words: "... The program conveyed the vision of wholeness as inspired by Swami Vivekananda's Message. Over ten thousand participants benefited directly from this program. The grand success of this program was the tremendous enthusiasm generated by the over 2000 youths from around the world who participated in the Conference."

Two others related to Jack's ministries in Oklahoma City, Oklahoma and West Newton, Massachusetts. In Oklahoma City, Jack [preached at the 100th anniversary service, celebrating the centennial of the church's founding. Dorothy and Jack also led a forum on "Life in the Church and in the City during our Ministry there." The West Newton UU Church hosted the Sabbath services of Temple Shalom while its building was being erected. Jack was minister of the UU Congregation at the time.

David van Strien Reports Some Exciting Travel:

"I took advantage of an opportunity to join with a group from the Sierra Club in following the Silk Road from Xian, the ancient capital of the Middle Kingdom, westward across China to Chinese Turkestan where we traveled from oasis to oasis across the Gobi and Telemaken Deserts to Kashgar. From there we went south over the Ramirs, Karakorams, Hindu Kush and Himalayas, ending up in Islamabad in the Indus Valley. It was the same route over which the Manicheans, Nestorians, Buddhists, and Islamic groups spread their respective faiths. The trip exceeded my expectations, which were extremely high!"

PIRFARE BARGA'


In response to a request, the Editor has undertaken modest research in the field of Senior Discounts on airline travel. Most airlines routinely offer a 10% discount on any fare. A more attractive arrangement for middle- and long-distance travel is offered in the form of coupon booklets. Most airlines offer 4 and 8 coupon booklets. Each individual must have his/her own booklet. Each coupon entitles you to a one-way ticket to any destination within the contiguous continental United States. Some also include travel to Hawaii, Puerto Rico and the Virgin Islands. Others require two coupons for these destinations. Seating, however, is limited on each flight, so travel plans should be made well in advance. Fourteen day advance reservations are required. Coupons also are accepted on a "standby" basis. This means you can go on a flight that is not completely filled at departure time. Coupons are good for one year from date of purchase, although if reservations are made within the year, travel can extend beyond the year. Generally, there are no other restrictions, no blackout dates, no weekend travel requirements. Coupon booklets are refundable if no coupon has been used. 4 coupon booklets sell for \$500-\$600; 8 coupon booklets for \$1000-\$1036. This information was obtained from American, United, Continental, Delta, TWA, and USAir. Your travel agent can help you with further details.

The coupon booklets offer fares for middle- and long-distance travel that are substantially below regular quoted fares and also are lower than many "special" fares, which often entail restrictions of one kind or another. For short distance air travel, the 10% discount is often a better choice. The usual lower age limit for eligibility for Senior Discounts is 62. When you read about UURMA conferences in distant places, consider coupon booklet fare costs. They may make your attendance affordable.

Continuing the dialogue ...

RETIRED MINISTERS' RELATIONS

Dear Gordon:

I believe that in the current *Guidelines* of the UUMA, regarding retired ministers, the UUMA overstepped its bounds, for in effect, the *Guidelines* subvert the First Amendment rights that apply to all - including clergy. Since most UU clergy give lip service to these rights, it seems unseemly for them to deprive others of these unalienable blessings to soothe their own insecurities.

I have, in the past, abided by the guidelines but believe the UUMA exceeded its authority when it sought to make retired ministers and their spouses "intellectual eunuchs" and "social zombies." In my opinion the present *Guidelines* violate the first five "Principles" that we are supposed to "affirm and promote."

I believe *Guidelines* have a right to advise on matters of ecclesiastical and professional activity but not on matters that affect the rights and duties of all church members.

I believe the UUMA has a right to expect retirees and their spouses to be guided by the common decencies and common courtesies in dealing with their successors -- as with all people. The retirees should recognize that they are retired and have no right to encroach on the professional and ecclesiastical rights of their successors.

The current policy, that seems to be encouraged, of acting as if retired ministers do not exist and whose presence is an unwanted alien substance in the church organism, is an unproductive arrangement and unnecessarily deprives the religious fellowship of many tangible and intangible contributions. It can also create in the incumbent clergy some unhealthy and unappetizing behavioral modes.

I believe the "Western Section" has opened discussion on a subject that very much needs attention. It has the potential of making improvements that could enrich our movement.
