

PAN-SOUTH CONFERENCE

Nineteen retired ministers and partners gathered in New Orleans in mid-March for one of the best southern conferences ever, thanks to the excellent organizing work by Al D'Orlando and his wife Cathy, and the hospitality of New Orleans First Church and its minister, Suzanne Meyer.

Sister Helen Prejean, author of the book "Dead Man Walking," was to have addressed us on Tuesday morning on death penalty issues. However she had to cancel when a close friend afflicted with terminal cancer became worse. We were fortunate, however, to have a young attorney who specializes in capital cases and an associate of Sister Helen, speak to us; Denise LeBoeuf gave us an eloquent and moving overview of the issues involved in working with death-row inmates.

Two other speakers completed the formal program: a history professor gave us insights into New Orleans history, and the director of the Southern Institute spoke on "Civil Rights: the Unfinished Revolution.

This conference, and its organizers, were extolled by outgoing UURMAPA President Max Gaebler as setting a high standard for midwinter southern conferences. An attempt will be made to find an attractive site on the eastern seaboard, perhaps Savannah, Georgia, for next winter or early spring.

NORTHEAST CONFERENCE

The Twelfth Annual Northeast Conference will be held Oct. 8-10, 1997, (not Oct. 7-9). Our presenter will be Harvey Cox who will address issues of cultural diversity and the religious community's responsibility in this area. The rest of the schedule is not firm at this time, but it will include worship, reports from the Ministry Department, time to snooze and get reacquainted, etc. Planned free time activities are a tour of Slater Mill Historic Site, a trip to Diamond Hill Vineyard, or smoozing with friends.

Again we'll be gathering at the LaSalette Center for Christian Living in Attleboro, MA.

This year the cost of the retreat is \$110.00. Please remember that LaSalette requires a fee of \$10.00 per day for those not staying overnight, in addition to meals. Subsidy funds are available through Dorothy Boroush, so don't let money keep you from being with us.
