Suggested Amendments to UUMA Code of Professional Practice and Guidelines

#### A PARABLE

And it came to pass that a decree went out from the Sanhedrin to all the shepherds in the land, concerning their decorum with each other. Indeed there was much written about those shepherds who, having served in he pastures of the Lord, now sought quieter days. The epistle admonished them to cease from guarding their sheep of old for in their wisdom and skill they still held the admiration of many in former flocks. And they were even advised to "move to a foreign land."

There was a certain servant of the Lord who resided in the Northeast. He and his father before him had guided many flocks through "the valley of the shadow of death." He now desired to lay down his staff and pursue the trade of carpentry. Yet still the people called upon him to shepherd them in joyful times and sad and on the Sabbath as well. And he agreed for he was of gentle heart and eager to serve.

One day there came a messenger pleading that he travel to a nearby city to address a sister-hood whose shepherdess had taken a sabbatical. He accepted and promised to appear on a given day. But lo! the shepherdess had not departed. When she heard that the venerable shepherd was coming to address her flock she forbade him to enter her valley. She rent her garments and cried out in anguish to the Council.

They listened with compassion to all that had happened to her and her flock. In its wisdom the Council agreed that she had been wronged and that the shepherd/carpenter must be brought to account.

The old shepherd was rebuked and suspended from gathering with his beloved colleagues. He was further admonished not to appear at their assembly until such time as he confessed his sins, repented, and took a solemn oath to abide by the letter of the decree from the Sanhedrin.

#### WHAT IS A LIBERAL?

When some of us entered the liberal ministry about fifty years ago, the word "liberal" meant that one bearing that label was willing to listen with some degree of courtesy to all sides of every question. We believed that this was the way to find TRUTH.

How is "liberalism" doing now?

I do not hear of any conservatives being invited to speak to UU churches and fellowships. I do not hear of any UU ministers publicly opposing abortion, or opposing affirmative action, or opposing "women's liberation." Should we not hear once in a while from the likes of Bill Buckley? I am told by some that such would be a waste of time.

William H. Willimon is Dean of Duke University Chapel. Speaking at the General Assembly in Charlotte, he said as a person NOT a Unitarian Universalist, "You say you are Universalists. What does that mean? Are you really able to tolerate differences, or do you, like most liberals, insist that people first surrender their differences in order to be accepted?"

Is there a danger that, by going so far over to one side in our view, we might miss a chance for compromises, or at least some understanding, with our opponents?

Might we not approach dogmatism if we only listen to our own views? Is there not a danger that we will become, in some measure, like the fundamentalist we oppose? Will we become so unified in our "liberalism" that our "Liberalism" will become a dogma, a creed, which we always said we would not embrace?

There are many questions to be asked and much study to be done on controversial issues. Some important books are coming out on various sides to these questions., Let's read and discuss them all.

Paying attention only to our own point of view is a prescription for strife and upheaval.

#### From The Rev. Wayne B. Arnason, President, UUMA - September 13, 1994

#### Dear Gordon:

... I must respond to the letter from David Van Strien in your August 1994 issue of *Elderberries*, since I believe it misrepresents the content of the *UUMA Guidelines* and what they require.

There is a single sentence in our *Guidelines that* specifically applies to retired ministers: "Retired ministers who join a church other than the one they have served, must exercise particular care that their experience, status, and prestige be enlisted only in support of the minister." Readers are then referred to the Code of Professional Practice for a review of parts of the code describing collegial relationships that apply to all UUMA members, including those who have retired. They describe appropriate procedures for ministers who are members of a colleague's congregation to accept engagements for professional services in such a way that the incumbent minister is comfortable and supportive of these engagements., These paragraphs have received considerable scrutiny in recent years. I acknowledge that some UURMA members are uncomfortable with them. I would welcome any new draft language that the UURMA Exec or individual members want to propose to improve these sections of the Code of Professional Practice.

... In particular, I am sure that it is difficult for ministers who retire and continue to be members of the congregations they have served to live with the following sentence in the Guidelines: "the former minister must play no role and express no opinions concerning the internal or external workings of the church as an institution."

... This sentence was not added to the Guidelines in recent years. It is a line that has been there in one form or another since the inception of the Guidelines., It was first written and approved by the generation of ministers that are now members of the UURMA.

The Guidelines recognizes that ministers who are members of congregations that they previously served have the power to play both positive and destructive roles in the congregation. ... In my view, flagrant and persistent violation of this guideline is a just cause for a colleague to bring a grievance to the UUMA, or for a church board to bring a "conduct unbecoming" to the MFC.

... We are talking about our agreements with each other as professionals about what best serves the interests of our congregations and our movement as we function in our professional roles. We have decided, as ministers within the UUMA, that we will forego some of the rights that we might have as members of the congregations, recognizing that they individual exercise of those rights by those who have formerly served as minister can be destructive in a congregational conflict.

... I would hope that the UURMA's's regional conferences might include some discussion of these issues, and possibly some focus on the very real sacrifices and emotional struggles that retired ministers must endure when they choose to remain members of the congregations they have served. ...

....I feel pressed to respond to Mr. Van Strien's complaint since the basis of it - that the UUMA "overstepped its bounds" with respect to minister's First Amendment rights - reflects an American national bias which is unnecessary to his argument and blind to the presence of Unitarian Universalist ministers and laypersons outside the United States.

While the United States Constitution is a landmark document in the history of democratic institutions, it astonishes me that so many of my American friends view it (and utilize it) as some sort of sacred scripture. It is, in fact, a secular document which establishes the civil authority of a particular nation. Although many of the values expressed in the American Constitution also find expression in Unitarian Universalism, the Constitution is not the sourceof our religious values.

.... As a Canadian, the more troubling issue for me is the tendency of many well-meaning Americans to view the laws and customs of the United States as universal. This has often led to a disturbing tendency to expect those living outside the U.S. to abide by its laws and practices. No matter how passive or good natured this expectation may be, it amounts to cultural imperialism. ...

Suggested Amendments to the UUMA Code of Professional Practice

#### Section 2. COLLEAGUES

### Seventh Paragraph - First Sentence

Present wording: "I will inform my colleagues in advance of any public engagement I may accept in his or her community or church, which might bear upon congregational issues or policies."

PROPOSAL: "I will inform my colleagues in advance of any public engagement I may accept in the church which he or she serves, which might bear upon congregational issues or policies."

### Ninth Paragraph - First Sentence

Present wording: "If I am a member of a colleague's congregation, I will in all ways honor the priority of his or her call to the ministry of that congregation, and I will carefully shun inappropriate influence which other members may tend to yield to me."

PROPOSAL: "If I am a member of or a participant in a congregation served by a colleague, I will in all ways honor the priority of his or her call to the ministry of that congregation. My participation in the life of the congregation will reflect my commitment to the well-being of the church, to my right to participate in its deliberations, to the congregation's decision-making authority in matters of policy, and to respect and support my colleague in his or her called ministry to the congregation."

Article IX - Other Ministries Section C - Ministers Emeriti/ae MOITO 33

#### Sub-Section 3 - Second Sentence bevies evan yeds eno eds mads

Present Wording. "The incumbent minister should endeavor to make the other welcome and valued when there are church occasions appropriate for the minister emeritus/a to attend."

PROPOSAL: Strike out the clause, "when there are church occasions appropriate for the minister emeritus/a to attend."

## Sub-section 3 - Third Sentence GERITER TRIJARREVINU MAIRATINU

Present wording: "The minister emeritus/a should be supportive of the incumbent and should not offer solicited or unsolicited advice or criticism to the members of the congregation."

PROPOSAL: Add at the end of the sentence, "regarding the ministry of the called and settled minister."

PROPOSAL: Renumber sub-section "7" to "6" and sub-section "6" to "7".

## Subsection 6 First and Second Sentences. It will design and second Sentences.

Present wording: "If the minister emeritus/a cannot make the transition, it is his or her responsibility to sense this fact. Ultimately she or he may have to move to another community and sever all ties to avoid damaging the ministry of a successor."

PROPOSAL: "If problems arise in achieving an effective transition, an exploration of possible remedial steps is necessary. Such a situation indicates the desirability of third party intervention by a Good Officers Representative, a District Executive and/or a person or persons skilled in conflict resolution."

Present wording: "The Minister must play no role and express no opinions concerning the internal or external workings of the church as an institution."

PROPOSAL: "The former minister may participate in the deliberations of the congregation of which he/she is a member or a participant. This participation must be guided by his/her responsibility to support the settled minister's prerogatives, and to avoid public or private criticism of the settled minister's performance of professional services."

#### SECTION E - Retired ministers O noitoed selitated redio - XI elotitA

Present Wording: "Retired ministers who join a church other than the one they have served must exercise particular care that their experience, status and prestige be enlisted only in support of the minister." Insumular edit particular care and support of the minister."

PROPOSAL: "Retired ministers who join or participate in a church other than one they have served should exercise particular care that their experience, status and prestige be devoted to the support of the church and its ministry."
