herewith some notes in preparation for our meeting next week...

 A major focus of these past few weeks has been considerations around holding some kind of in-person UURMaPA Board gathering. As you saw, I took a stab at an agenda, for planning purposes, after Anne Spatola generated some excellent lodging and meeting suggestions.

The news of a new virus variant slowed those plans and ideas considerably. Thus in this next meeting we will need to determine if we can reasonably plan for an in-person gathering in February 2022. And if not, what can we do to address some of the issues that have come before us?

• In reflecting on this, I feel that it may be possible to have a longer virtual workshoptype of meeting to figure a way to generate a UURMaPA covenant [following what seemed to be the direction we were headed regarding the proposed Retired Ministers UUMA Chapter: that we instead focus on covenant and good offices and table the Chapter idea].

I strongly feel that strategic planning to address welcome and inclusion and BIPoC UURMaPAns [plus continuing antiracism efforts and working on issues around white supremacy culture and structures...] needs to be some kind of in-person, sustained effort. I can't see doing it in a virtual sense - but I may be very wrong on that... (*)

- sent condolence cards (and posted notes when a card wasn't possible) for seven deceased UURMaPA ministers.
- arranged for UUA InSpirit bookstore gift certificates to be sent as a "thank you" to UURMaPA Fall Conference planners.
- Still pondering when we will be ready to make some proposals and plans for UURMaPA Conferences beyond this "winter"... we are operating on assumptions that there will be a return to how things were in the "before-time", yet I still wonder about UURMaPA GA events and conferences.

Propose a Program – You are warmly invited to <u>submit a Program Proposal</u> for the 2022 UUA General Assembly - a Multi-Platform GA which will have live in-person programming, live webinar programming, and prerecorded on-demand programming. The theme for GA 2022 is "Meet the Moment: Reimagining Radical Faith Community." Proposed programs should provide meaningful opportunities for learning and skill development, as well as address one or more of the following focus areas:

- Opportunities to reimagine and embody our radical and liberating theology
- Skills to Level Up to meet urgent justice needs of the moment
- Strengthening our Community of Communities through connections and skill building

The program proposal deadline is Friday, January 14.

Propose a Worship Service – We are inviting organizations and worship leaders with experience and capabilities to self-produce a complete, high-quality, 45-minute worship service to <u>submit a GA Worship Proposal</u>. Proposals can be for a live worship (in-person or virtual) or for a fully prerecorded video presentation. Select proposals will be featured in-person in Portland on Thursday, June 23, Friday, June 24 and Saturday, June 25 at 8:15 a.m. These worship services can be either a live event or a live screening to an in-person audience of a prerecorded service. These worship services will also stream live to virtual registrants. Other proposals will be selected to be fully prerecorded and made available for on-demand viewing. The worship proposal deadline is Friday, January 14.

December Board Report for Anne Spatola

With the conclusion of the fall conference behind us, this month has been somewhat less hectic. After costs were totaled, the conference resulted in a profit of \$2485. I have not seen any new information regarding evaluations. Preliminary results were very positive overall and some comments were shared at the November meeting. Rosemarie Smurzynski consolidated all of the individual pieces (written by the planners) on the conference and submitted to Jaco for inclusion in the next issue of Elderberries. It is very well organized and presented and gives an excellent summary of the 3 day event.

With focus on the winter conference, Wayne and I had a few discussions on the possibilities for the Odyssey presenters. He was successful in acquiring positive responses from one minister and a partner. Names were sent to Susan for formal invitations.

Anne Hines and I also had a few contacts regarding the challenge of finding celebrants for the Service of Remembrance and the closing worship. It seems that the requirement for pre-recording was a major factor in their declining. I gave her more names to contact with some suggestions.

- Compared several hotels in Marin county for the February retreat. Made direct contact with two and sent info to Susan.
- Prepared and facilitated conference planning meetings on November 16 and December 14.
- Wayne contacted and secured Odyssey presenters
- Anne Hines is trying to find ministers for the Service of Remembrance and closing worship
- Fritz and Walt are working on a 2 session 3 day schedule and possible small groups
- Working on several budget scenarios utilizing a one fee schedule
- Contacted my local congregation for conference room availability. Our minister is very happy to host our group. Also reviewing any changes in county infections. Currently, county is at 89% vaccination rate for all residents 5+ years old. No evidence of omnicron or increase in hospitalizations. Masking is still prevalent in indoor settings throughout the county.

volunteer commitment I made to the winter conference planning team to be the contact for the Odyssey presentations. I enjoyed talking to possible candidates, and also noted that preparing a virtual presentation is a concern for some potential Odyssey presenters. Susan will be reporting to us on her follow up with recommended candidates.

As Anne Spatola has noted in her report, I followed up this month with the

I am the person who is now on other end of the email address: goodoffices@uurmapa.org and I had my first invitation this month to support a retired colleague facing a complaint from an active younger colleague. I may need to refer this person to a someone else with Good Offices experience if this case was to end up in front of the MFC, but I hope it doesn't go that far.

At our last Board meeting, I said I would follow up with Melissa Carvill Ziemer of the UUMA Executive Team to report on our desire to set the chapter idea on the back burner for now and to explore her ideas about how to move forward with a process for covenant building and models for Good Offices for situations involving retirees.

Melissa was supportive of the UURMaPA Board's direction and offered to be of whatever help she could in developing a process for creating a draft UURMaPA covenant that could be affirmed by both ministers and partners. In our conversation we reviewed the concerns about membership and covenant that had brought the idea of a retirees' chapter to the fore. Since UURMaPA membership is open to all fellowshipped UU ministers and their partners, without regard to whether the ministers choose to be members of the UUMA, we have had concerns that some active UURMaPA members would be outside the Covenant, Code, and Guidelines of the UUMA. However, reviewing membership statistics, we realized that there are currently very few participating UURMaPA members who fall into this category, and no active leaders. We both saw the possibility of working on a covenant that could be affirmed by all UURMaPAns (partners and ministers) as a positive process of engagement about what we promise to each other and the congregations of the UU Association as members of UURMaPA.

Regarding the ways that UURMaPA might participate in the new structure for the UUMA's Good Offices, the conversation produced two new possibilities that the Board can consider. The first is to take advantage of the UURMaPAns who are already serving as Good Offices Persons for their UUMA Chapter or for

one of the newer identity-based chapters. We quickly thought or four or five! These colleagues have already had UUMA Good Offices training, and although they are not identified as specialists in Good Offices issues involving retirees, they already have experience that might be brought to bear and be willing to be in service if asked. They at least could be a focus group to help the Board and the UUMA executive in thinking about next steps. Melissa has offered to convene such a focus group to invite their thoughts.

The second possibility considered was whether UURMaPA might instigate a dedicated team of "coaches" for dealing with issues in retirement. We recognized that this function often happens informally among friends. It's also true that some of our retired colleagues are less well connected than others and would take advantage of a defined role for a UURMaPA coach. Partners in particular can be isolated from the experiences of other partners as they try to navigate their role in a congregation their spouse has retired from or a role in a new congregation near a new retirement home. While not intended to be a Good Offices role, the coach could possibly help head off conflicts through advice about best practices for congregational participation by retired professionals and their spouses.

I will be submitting a version of this report for publication in Elderberries in order to promote transparency in our discussions but also as an invitation for UURMaPA and interested UUMA members, especially those with Good Offices experience, to share any thoughts or ideas they may have.
