Secretary - Gloria Perez

Wayne added new information to his report. There was a seminar, presented by Jan Gartner, regarding new guidelines for congregations in their approach to ministerial compensation. Also, there will be a new vendor for the retirement fund yet to be determined.

Connections Chair Report to the UURMaPA Board — Millie Rochester

Here is a summary of my activities since the Board last met:

- Communicated with fellow retirees via email, text and phone
- Attended the Welcome Luncheon at GA, and brought the banner home with me
- Attended the virtual Welcome gathering via Zoom
- Met via Zoom with Joy Atkinson to discuss our job descriptions and made some changes
 - "Writes welcome notes for new members and partners when Intent to Retire forms are filed and notifies Area Connectors" can be shifted to the Connections Chair. Joy will send me the official UURMaPA stationary.
- Discussed with Joy the changing nature of Area Connectors as that role has evolved over time its effectiveness and even its necessity, given the many small groups that are organized according to interests and needs of members
 - I've been mostly unsuccessful in recruiting new Area Connectors (just one achieved in my year in this position).
 - Most ACs tell me that their contacts are sporadic at best, although a few gather with fellow UURMaPAns now and then.
 - We now have 8 vacancies, and I anticipate another when one moves to a different geographic area.
 - I want to stress that this does not diminish the effectiveness of sending welcome notes to newly retired ministers and partners, the coordination of minister and partner deaths, sending notes of condolence, communicating with the Membership Coordinator, and being generally available to meet the needs of our members who feel isolated.
- Discussed with Wayne via email his proposal of a mentoring program for newly retired ministers and partners, to be brought forward in the next couple of months.

This is an exciting time! It's my pleasure to serve with all of you.

Connections Assistant - Ann Schranz

I had a Zoom call with Joy Atkinson to begin to orient her to the position. I gave her "viewer" access to the obituaries database in the Board's Google Drive. As of July 1, I will change that to "editor" status. She'll shadow me on handling any minister or partner deaths in the coming weeks.

- Poem on hearing loss by Karen Lewis Foley? -- She contacted me but hasn't sent it to me.
 - Article on grief support group by Tom Korson

Regarding my "covenanting" process comments sent in a separate message, I might elaborate that "continuing education" could also be thought of as "religious education." My opinion is that as we age, in some senses, we become more childlike in terms of abilities, including cognitive abilities. So maybe we older people need more concrete lessons instead of solely conceptual ones, and maybe we need more repetition of lessons than we did at whatever our cognitive "peak" was.

I'm also thinking about trying (as a Board) to change the course of the ocean liner that is UURMaPA regarding troublesome boundary violations -- getting in the way of our successors and making life harder for former congregants -- and regarding intentionally

welcoming BiPOC members. I'm thinking we might be most effective doing what we can as an executive Board, using repetition and concrete examples as much as possible rather than more elaborate, conceptually based processes. I reserve the right to change my mind! These are part of my "thinking out loud."

Report of the At-Large Member for UUMA/UUA Relations - Wayne Arnason

After General Assembly was over, I slid into a month of complicated travel, health issues, and emotions, and let UURMaPA work go until this past weekend. In June I submitted the Elderberries article summarizing the outcomes of the May focus groups on our covenant study, and supported the UURMaPA events at GA, and that has been about it for me .

My wife and I contracted covid, probably at GA, so our staggered quarantines preoccupied much of early July. We recovered by the time of our visit with our daughter's family mid-month, just in time to pick up a bronchitis bug from one of the grandchildren. I recovered quickly, but it laid my wife low for a full week of our late July vacation time in Canada with my family.

Rob Eller-Isaacs' death and my mother's memorial service added an overlay of grief on top of all this illness, so when we had periods of good health and joy with family, I just wanted to enjoy that and not manage much else.

During the week between submitting this report and joining our August meeting, we will be moving our extra apartment kit from our home in Charlottesville to the new apartment in St. Paul and settling in there.

I have started up the promised conversation with Millie about next steps for a volunteer support program for retirees entering their first year. We hope to be able to have some agenda time on this subject at our September Board meeting.

After Mark Ward's untimely death, Barbro asked me if I could be the contact and support person for the Odyssey presenters, although Susan has done much of the communication to possible presenters thus far. We will hear more about where that stands at our meeting.

The one agenda item I did offer to set up for this August meeting involved some reflections to prime the pump for our conversation about the next steps in the year of study of a possible UURMaPA covenant, so here we go – probably at excessive length:

My first thought about next steps and the year of study is that our Board needs to recognize that this is ultimately a strategic leadership decision on our part, and not a discernment through conversation of a consensus among the membership. There won't be a consensus and our decision about how to go forward will disappoint, annoy, or maybe even drive away some people. We should recognizer and accept that.

My second thought, and one that I made pretty clear in the article for Elderberries, is that the covenant conversation inevitably involves what it means for UURMaPA to somehow make a different commitment to de-centering our white cultural context. Since this is the water in which we swim, we are having the same experience we

have all been through before in other UU institutions we engage with. Some people don't see the need for or resent the conversation, and others carry wounds from their previous engagements, or are just plain tired of it, and want to claim the white privilege of not having to think about it. Other people are passionate about affirming such language to the point of obnoxiousness and those two poles within the UURMaPA membership will be in tension. Of course, making some kind of commitment to decentering whiteness is not the only value that will be held up in a UURMaPA covenant, but it will be impossible to not have that come up and to be important in whatever we put forward as possible statement.

I think we can safely say that most people in the focus groups wanted the conversation to continue. I have suggested a few ways that this could happen leading up to the fall conference:

- (a) Organize a second opportunity to join another round of focus groups and give more people the opportunity to participate in that format. Taking this approach would be based on whether we think the sign up and participation in the focus groups in the spring did not exhaust the possibilities for that approach.
- (b) Take the initiative as a Board to build on the feedback we have received and work over the next six weeks towards a new draft statement that could be publicized and discussed in one of the small "interest-group" one-hour segments at the fall conference and see who turns up and what happens there. We could make it clear that we still see this is part of the study year and not a hard decision but indicate that the Board would like to get more concrete this fall about the content of a statement and move further towards exploring how it could be affirmed.
- (c) Use the "interest group" opportunity at the fall conference to have a wideopen conversation about the results of the focus groups as described in the Elderberries article, without having anything further to present. In that approach, we see if the same people or usual suspects choose to attend, or if the article draws any new interested people, and we monitor how the conversation goes and evaluate where we are at the November meeting.

As I said in the Elderberries article, and previous communications within the Board, I think that there is some rich conversation happening in the UUA and UUMA now about the meanings of covenant, and how seriously we take the covenants we already have. Mykal Slack's Berry Street lecture at GA following the Commission on Appraisal 's recent report has brought Kathleen and I back to re-reading Alice Blair Wesley's amazing Minns Lectures from fifteen or so years ago. There's a lot to talk about in all these reflections.

You all may have other possibilities to offer about what we do next, but I hope these options will get our thinking started. I'm looking forward to seeing you on the 17th.
